**In the One Hundred and Eighty-Ninth General Court  
(2015-2016)**

An Act authorizing the Nantucket Islands Land Bank to convey certain parcels of land held for open space, recreational or conservation purposes to the town of Nantucket for open space, recreational or conservation purposes.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           Section 1. Pursuant to Article 97 of the Amendments to the Constitution of the  
2 Commonwealth of Massachusetts and notwithstanding the provisions of any general or special  
3 law to the contrary, the Nantucket Islands Land Bank may transfer, sell, convey or otherwise  
4 dispose of certain parcels of land situated in the Town of Nantucket to the Town of Nantucket  
5 for open space, recreational or conservation purposes and described as follows:

7           Assessor's Map 67, Parcel 121 (portion of)

8           Assessor's Map 67, Parcel 400

9           Assessor's Map 67, Parcel 401

- 16 A portion of Pilot Whale Lane abutting the parcels described above.
- 17 Section 2. This act shall take effect upon its passage.
