Adjournment in Memory of Clifton K. Snuffer, Jr.

The Senator from Norfolk and Suffolk, Mr. Rush, moved that when the Senate adjourns today it do so in memory of Clifton K. Snuffer, Jr.

Clifton Snuffer, Jr., a longtime local elected official of Walpole, passed away on Monday, January 23, 2023, after a full life and valiant battle with cancer. Selectman

Snuffer began his career in 1982 as an elected town meeting representative, a post he would hold across four different districts over the next 36 years where he distinguished himself for his oratory as well as "points of personal privilege". In 1982, he began stints on the Finance Committee-serving as chair, the Capital Budget Committee, and the Cable Advisory Committee. In the 1990s his focus honed on the preservation of Open Space and he served on the Isaac's Land Study Committee which led to the purchase of what is now called Adam's Farm for conservation and recreation, as well as the Soccer Committee, and Growth Control Committee. The culmination of his public life where his terms as Selectman, from 2008-2011 and 2013-2016- where he was instrumental in the successful completion of new Police, Fire and DPW stations, as well as his beloved Senior Center.

Ever affable and verbose, Selectman Snuffer was a happy warrior for the people of Walpole, a budget hawk, and a boundless fount of ideas for public policy. In his later years he reveled in his grandchildren his art and "his" senior center.

The thoughts and prayers of the Senate are with Mr. Snuffer, his family, his innumerable friends, and the community of Walpole who mourn him in this time of grief.
