# JOURNAL OF THE SENATE

Thursday, April 11, 2024.

Met at ten minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Brownsberger), members, guests and staff then recited the pledge of allegiance to the flag.

# Distinguished Guests.

There being no objection, the following guests were introduced:

The Chair (Mr. Brownsberger) handed the gavel to Mr. O'Connor for the purpose of an introduction. Mr. O'Connor then introduced, in the rear of the Chamber, the Duxbury High School girls hockey team and the Duxbury High School football team. The girls hockey team was recognized for winning the 2024 MIAA Division 2 State Championship title. The football team was recognized for winning the 2023 MIAA Division 4 Super Bowl title. The teams were led by Head Coaches Matt Landolfi and Dan Najarian. Both championship teams were honored for winning back-to-back state finals and for showing resilience and a high level of athleticism that elevated them above all other competition. The Senate applauded their accomplishments and they withdrew from the Chamber.

Mr. Brady then introduced, in the rear of the Chamber, the former California State Comptroller and California gubernatorial candidate, Betty Yee. The Chair (Mr. Brownsberger) handed the gavel to Mr. Crighton and Ms. Lovely for the purpose of an introduction. The Senator from Norfolk and Plymouth, Mr. Keenan, the Senator from the Cape and Islands, Mr. Cyr, and the Senator from Suffolk, Mr. Collins moved that when the Senate adjourns today, it does so in memory of William Delahunt.

Born on July 18, 1941, William David Delahunt grew up in Quincy, the son of Ruth

Bill Delahunt graduated from Thayer Academy, Middlebury College, and Boston College Law School. He served as a radarman in the U.S. Coast Guard in 1963 and in the Coast Guard Reserve from 1963 to 1971.

Mr. Delahunt won election to the Quincy City Council in 1971. He served a term in the Massachusetts House of Representatives from 1973 to 1975 before Governor Michael Dukakis appointed him to fill the vacant seat of Norfolk District Attorney, a position he held from 1977 to 1997. After the retirement of U.S. Representative Gerry Studds, Mr. Delahunt triumphed in a close election in 1997. He served in the U.S. House of Representatives until 2011, building and then cementing his reputation as a great uniter, reaching out and working across the aisle for the betterment of all.

As Norfolk County District Attorney, Mr. Delahunt created the first program to address domestic violence, sexual assault, and child abuse establishing a unit to investigate those crimes and to prosecute the offenders. This program became a national model. He played a crucial role in establishing and sustaining the first domestic-violence shelter on the South Shore run by the wonderful nonprofit DOVE, Domestic Violence Ended.

DOVE later honored Mr. Delahunt with an award because "William Delahunt has always led by example, especially as a key supporter of DOVE and our partner organizations, and a champion of efforts to end violence against women, men, and children. He has consistently and loudly used his voice and position to advance our work, and <u>he has made a difference</u>."

Those lucky enough to know Bill Delahunt could not help but love the man. With arms folded, a breaking smile, a twinkle in his eye, and quick wit, everyone knew that he enjoyed a little fun as much as he enjoyed his work. A hard worker who accomplished a great deal, he took his job but not himself seriously. We will always remember his charm, kind smile, and sense of humor. And, above all, he was a devoted father who adored his family.

Bill Delahunt accomplished much at the city, state, and federal levels on domestic and international issues. Most important, he left an indelible impression as the kind of person who would make you feel better for having had the opportunity to interact with him.

William Delahunt leaves his fiancée, Julie Pagano; his daughters, Kirstin of Dorchester and Kara Delahunt Bobrov of Milton; and two grandchildren.
