**In the One Hundred and Eighty-Ninth General Court
(2015-2016)**

An Act authorizing the town of Lakeville to convey certain property to the city of Taunton.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Notwithstanding any general or special law to the contrary, the town of
2 Lakeville may convey to the city of Taunton two parcels of land for water supply and
3 telecommunications support purposes, one of which is a parcel of land located on Kenneth
4 Welch drive and Rhode Island road, identified on assessors’ map 060-008-019, which includes
5 water service facilities and improvements, and the second of which is a parcel of land located at
6 8 Montgomery street, identified on assessors’ map 018-002-002, which includes a pump station
7 and other water service facilities and improvements.

8 SECTION 2. This act shall take effect upon its passage.
