**In the One Hundred and Eighty-Ninth General Court  
(2015-2016)**

An Act authorizing the town of Foxborough to grant three additional licenses for the sale of all alcoholic beverages to be drunk on the premises.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. (a) Notwithstanding section 12 and 17 of Chapter 138 of the General laws  
2 or any other general or special law to the contrary, the licensing authority of the town of  
3 Foxborough may grant 3 additional licenses for the sale of all alcoholic beverages to be drunk on  
4 the premises pursuant to section 12 of said chapter 138 subject to the conditions set forth in this  
5 act.

6           (b) The licensing authority of the town of Foxborough shall restrict all of the licenses  
7 authorized in this act to business entities located within the site containing a development to be  
8 known as Downtown Foxborough, as more particularly shown on a plan which is on file with the  
9 board of selectmen, hereinafter referred to as the “site”. A license granted pursuant to this act  
10 shall be clearly marked on its face “Downtown Foxborough Only” and shall be subject to all of  
11 said chapter 138 except said section 17.

12           (c) Notwithstanding said section 12 of said chapter 138, the additional licenses authorized  
13 by this act shall be subject to an original license fee of \$5,000 in addition to the annual fee for

14 existing all alcoholic beverages or wines and malt beverages licenses, as applicable, in the town  
15 of Foxborough, due and payable upon the original granting of any such license and also upon  
16 reissuance of such license pursuant to subsection (e) or (f). Said additional \$5,000 fee shall be  
17 deposited into an economic development account in the town and expanded consistently with the  
18 purposes of such account.

19 (d) Prior to the granting of a license pursuant to this act, the licensing authority of the  
20 town of Foxborough shall determine whether an applicant meets the criteria set forth in this act,  
21 consistent with the rules and regulations governing licenses for the sale of alcoholic beverages  
22 promulgated by the licensing authority of the town of Foxborough and all other applicable laws.

23 (e) The licensing authority of the town of Foxborough shall not approve the transfer of a  
24 license granted pursuant to this act to a location outside the site, but it may grant a license to a  
25 new applicant within the site if the applicant files with the licensing authority a letter from the  
26 department of revenue and a letter from the department of unemployment assistance indicating  
27 that the license is in good standing with those departments and that all applicable taxes, fees and  
28 contributions have been paid

29 (f) If a license granted to this act is cancelled, revoked or no longer in use, it shall be  
30 returned physically, with all of the legal rights, privileges and restrictions pertaining thereto, to  
31 the licensing authority of the town of Foxborough, which may then grant the license to a new  
32 applicant at a location within the site under the same conditions set forth in this act.

33 SECTION 2. This act shall take effect upon its passage.
