**In the One Hundred and Ninetieth General Court  
(2017-2018)**

An Act regarding the composition of the Boston Arts Commission.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Chapter 410 of the acts of 1898 is hereby amended by striking out section 1  
2 and inserting in place thereof the following section:-

3 Section 1. Notwithstanding any general or special law to the contrary, there shall be  
4 within the mayor’s office of arts, tourism and special events, or its successor, a Boston art  
5 commission which shall consist of 9 commissioners, all of whom shall be residents of the city of  
6 Boston, to be appointed by the mayor, 1 of whom shall be selected from 3 candidates nominated  
7 by the Boston Society of Architects, 1 of whom shall be selected from 3 candidates nominated  
8 by the Museum of Fine Arts, 1 of whom shall be selected from 3 candidates nominated by the  
9 trustees of the Public Library of the city of Boston, 1 of whom shall be selected from 3  
10 candidates nominated by the Isabella Stewart Gardner Museum, 1 of whom shall be selected  
11 from 3 candidates nominated by the Massachusetts College of Art and Design, 1 of whom shall  
12 be selected from 3 candidates nominated by the Institute of Contemporary Art, and 1 person who

13 has demonstrated distinguished service to the arts, appointed at the discretion of the mayor's  
14 office of arts, tourism and special events, or its successor, to ensure that the Boston art  
15 commission represents diverse perspectives on the arts. The director of the mayor's office of arts,  
16 tourism and special events, or its successor, and the head of urban design at the Boston  
17 Redevelopment Authority shall serve on the commission, ex officio and without additional  
18 compensation, and each shall have an official vote.

19 Commission members shall serve for terms of 5 years but, if invited by the mayor, a  
20 commissioner may serve for an additional 5 years. A vacancy on the commission shall be filled  
21 in like manner for the unexpired term and, after that term has expired, a successor commissioner  
22 shall be appointed for a term of 5 years. A commission member whose term has expired shall  
23 continue in office until a successor is appointed. Commissioners shall serve without  
24 compensation. The daily operations of the commission shall be run by a director, which shall be  
25 a paid position through the city of Boston.

26 The commission shall not be subject to the supervision or control of the mayor's office of  
27 arts, tourism and special events, or its successor, or any member thereof, and, unless otherwise  
28 ordered by the mayor, commission members shall not communicate with the mayor except  
29 through the mayor's office of arts, tourism and special events, or its successor, and shall not  
30 make an annual or other report except through the mayor's office of arts, tourism and special  
31 events, or its successor.

32 The commission shall adopt, and may from time to time amend, by-laws concerning its  
33 internal management and, after public hearing, may adopt and from time to time amend

34 regulations for the interpretation, implementation, administration and enforcement of this act and  
35 such regulations shall be in addition to those required by sections 2 and 3.

36           Annually on May 1 or as soon thereafter as may be convenient, the commission shall  
37 elect from among its members a chair and a vice-chair. The roles, powers and term limits of the  
38 chair and vice-chair shall be determined by the commission as provided in the by-laws. City  
39 employees shall not be eligible for the offices of chair or vice-chair.

40           The commission shall have all of the powers and perform all of the duties conferred or  
41 imposed by law on the board of art commissioners in existence immediately prior to the effective  
42 date of chapter 8 of the ordinances of 1953.

43           SECTION 2. This act shall take effect upon its passage.
