**In the One Hundred and Ninety-Third General Court
(2023-2024)**

An Act to modernize property tax abatements for veterans.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 There shall be established a special commission to study and recommend ways to
2 modernize and increase property tax abatements and exemptions for veterans and surviving
3 spouses available under M.G.L. ch. 59. The study shall include, but not be limited to: (i) a review
4 of the current tax abatements and exemptions for veterans and surviving spouses available under
5 the chapter; (ii) a determination of the relation of tax abatements and exemptions to United
6 States Department of Veterans Affairs disability rating, and; (iii) recommendations to create a
7 system of abatements and exemptions which link United States Department of Veterans Affairs
8 disability rating to abatement and exemption amount.

9 The commission shall consist of: two persons to be appointed by the Senate President,
10 one of whom shall serve as co-Chair, at least one of whom shall be a veteran; two persons to be

11 appointed by the Speaker of the House of Representatives, one of whom shall serve as co-Chair,
12 at least one of whom shall be a veteran; one person to be appointed by the Minority Leader of the
13 Senate, who shall be a veteran; one person to be appointed by the Minority Leader of the House
14 of Representatives, who shall be a veteran; the Secretary of the Department of Veterans'
15 Services or a designee; The Adjutant General of the Massachusetts National Guard or a designee;
16 the Director of the United States Department of Veterans Affairs Boston Regional Office or a
17 designee; the Commissioner of the Massachusetts Department of Revenue, or a designee; the
18 Executive Director of the Massachusetts Municipal Association or a designee; the Massachusetts
19 Department Adjutant of the Disabled American Veterans or a designee; the president of the
20 Massachusetts Association of Assessing Officers or a designee; and five persons to be appointed
21 by the Governor, one of whom shall be a Local Veterans Services Officer, one of whom shall be
22 a surviving spouse and no fewer than three of whom shall be veterans.

23 The commission may solicit input through public hearings and testimony.

24 The commission shall file a report of its findings and recommendations with the Clerks of
25 the Senate and House of Representatives and the Senate and House Committees on Ways and
26 Means not later than December 1, 2024.
