**In the One Hundred and Ninety-Third General Court
(2023-2024)**

An Act providing equity to police officers disabled by cardiac disease.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 94 of chapter 32 of the General Laws, as so appearing, is hereby
2 amended by inserting after the words "Massachusetts Bay Transportation Authority," the
3 following words: -

4 "or of the police force of the University of Massachusetts, or of the police force of the
5 Massachusetts Port Authority, or of the police forces of the state universities and community
6 colleges, or of the police force of the Executive Office of Environmental Affairs."
