The Commonwealth of Massachusetts

An Act An Act relative to the effective enforcement of municipal ordinances and bylaws.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. The first paragraph of section 21 of chapter 40 of the General Laws, as  
2 appearing in the 2008 official edition, is hereby amended by striking out the words, ‘three  
3 hundred dollars’ in line 5-6, and inserting in place thereof the words “one thousand dollars”.

4 SECTION 2. The fifth paragraph of section 21D of chapter 40 of the General Laws, as  
5 appearing in the 2008 official edition, is hereby amended by striking out the words, “three  
6 hundred dollars” in lines 44-45 and inserting in place thereof the words “one thousand dollars”.

7 SECTION 3. Section 21D of chapter 40 of the General Laws is hereby amended by  
8 inserting after the end of said section the following new tenth paragraph: --

9 Notwithstanding the foregoing provisions and any general or special law to the contrary,  
10 in any suit in equity brought in the superior court or the land court by any city or town, or any  
11 municipal agency, officer, board or commission having enforcement powers on behalf of such a  
12 city or town, to enforce the provisions of any lawfully enacted ordinance or bylaw, or any rule,  
13 regulation or order described in this section, the court, upon a finding that such violation  
14 occurred, may assess a civil penalty not to exceed one thousand dollars for each violation  
15 thereof. Civil penalties assessed under this paragraph shall be in addition to any equitable relief  
16 ordered by the court, and shall be paid to such city or town for such use as the city or town may  
17 direct. In considering any penalty to be assessed under this paragraph, the court shall consider (a)  
18 whether the violation was willful or negligent, (b) any harm to the public health, safety or  
19 environment resulting from the violation, (c) any economic benefit gained by the defendant as a  
20 result of the violation, (d) the cost to the city or town resulting from the violation, including its  
21 enforcement costs and reasonable attorneys fees, (e) any history of noncompliance by the  
22 defendant, and (f) whether the defendant made good faith efforts to cure or cease the violation of  
23 such ordinance or bylaw after the first notice thereof by such city or town.

24           SECTION 4. The second paragraph of section 7 of chapter 40A of the General Laws, as  
25 appearing in the 2008 official edition, is hereby amended by striking out the words “three  
26 hundred dollars” in lines 16-17, and inserting in place thereof the words “one thousand dollars”

27           SECTION 5. The third paragraph of section 7 of chapter 40A of the General Laws, as  
28 appearing the 2008 official edition, is hereby amended by inserting after the word “thereof” in  
29 line 49 the phrase “and, upon determination that such violations have occurred, may assess civil  
30 penalties therefore in accordance with the provisions of the tenth paragraph of section 21D of  
31 chapter 40 of the General Laws.
