An Act to clarify terms of collective bargaining agreements.

Whereas, The deferred operation of this act would tend to defeat its purpose, which is to declare and clarify the intent of Chapter 150E, , therefore, it is hereby declared to be an emergency law, necessary for the immediate preservation of the public safety.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Chapter 150E § 7(a) is hereby amended by adding the following at the end of the first
2 sentence:- "... provided that a provision in the agreement setting forth that its terms remain in
3 effect beyond three years while the parties negotiate a successor agreement is valid and
4 enforceable. This proviso shall be applied retroactively to agreement that contained such a
5 provision but otherwise expired prior to the effective date of this Act."
