Lovely (by vote of the town) that the town of Danvers be authorized to grant ten additional licenses for the sale of alcoholic beverages to be drunk on the premises. **In the One Hundred and Ninetieth General Court
(2017-2018)**

An Act authorizing the Town of Danvers to grant up to ten additional licenses for the sale of alcoholic beverages.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 1

2 (a) Notwithstanding the maximum number of licenses authorized to be granted under
3 section 17 of Chapter 138 of the General Laws or any other general or special law to the
4 contrary, the licensing authority of the Town of Danvers may grant up to ten (10) additional
5 licenses for the sale of alcoholic beverages to be drunk on the premises under section 12 of said
6 Chapter 138 to operators and locations to be determined in said town. The licenses shall be
7 subject to all said Chapter 138 except section 17.

8 (b) A license granted under this section shall not be transferable to any other person,
9 corporation or organization for three (3) years after the original issuance. A transfer in violation
10 of this subsection (b) shall render the license null and void.

11 (c) Notwithstanding sections 12 and 17 of Chapter 138 of the General Laws, the licensing
12 authority for the Town of Danvers may restrict said licenses issued pursuant to this act to holders
13 of common victuallers licenses.

14 (d) Notwithstanding any general or special law or rule or regulation to the contrary, the
15 licensing authority of the Town of Danvers may approve the transfer of the licenses granted
16 under this act to any other location. The licenses granted under this act may be reissued by the
17 licensing authority, if an applicant for the license files with the licensing authority a Certificate
18 of Good Standing from the Department of Revenue (or other required documentation
19 demonstrating tax compliance), indicating that the license is in good standing with the
20 Department and that all applicable taxes have been paid.

21 If the licenses granted under this section are cancelled, revoked or no longer in use, they
22 shall be returned physically, with all the legal rights, privileges and restrictions pertaining
23 thereto, to the licensing authority which may then grant the licenses to new applicants and under
24 the same conditions as specified in this act.

25 Section 2

26 This act shall take effect upon its passage.
