By Representative Speliotis of Danvers and Senator Lovely, a joint petition (subject to Joint Rule 12) of Theodore C. Speliotis, Joan B. Lovely and others for legislation to authorize employees of the Essex North Shore Agricultural and Technical School District to participate in certain benefit programs administered by the Commonwealth. Public Service.

The Commonwealth of Massachusetts

In the Year Two Thousand Fourteen

An Act relative to the Essex North Shore Agricultural and Technical School District.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 1. Section 13 of Chapter 463 of the Acts of 2004 as amended by Chapter 130 of
2 the Acts of 2010 is hereby amended by striking Section 13 in its entirety and replacing it with the
3 following:-

4 "SECTION 13. Beginning July 1, 2015, employees of the district shall be eligible to
5 participate in all group insurance programs and benefits administered by the group insurance
6 commission pursuant to section 16 of chapter 34B of the General Laws; but, the district shall
7 reimburse the commonwealth for costs of group insurance and benefits attributable to the district.
8 Until July 1, 2015, the district shall assume responsibility for the collection and payment of
9 premium costs for all benefits for any active employee absorbed by the district who is covered by
10 the group insurance commission on the date the Essex agricultural and technical high school
11 ceases to exist under this statute.

12 Section 13A. Employees of the district shall become members of the city of Salem
13 contributory retirement system, except that educators certified under section 38G of chapter 71
14 of the General Laws who are employed by the district shall be members of the teachers'
15 retirement system under chapter 32. Employees of the district shall be considered public
16 employees for purposes of tort liability under chapter 258 of the General Laws, and the school
17 committee shall be considered the public employer for purposes of tort liability under said
18 chapter 258."

19 Section 2. Section 18 of Chapter 463 of the Acts of 2004 as amended by Chapter 130 of
20 the Acts of 2010 is hereby amended by striking the number "13" and replacing it with "13A".
