4 963, 964, 968, 971, 974, 976, 981, 984, 1771, and 1772 and House documents numbered 708,  
5 790, 791, 1820, 1821, 1823, 1824, 1827, 1828, 1832, 1834, 1837, 1838, 1844, 1845, 1846, 1847,  
6 1849, 1850, 1851, 1855, 1863, 1866, 1867, 1876, 1878, 1881, 1884, 1885, 3429, and 3456,  
7 relative to miscellaneous issues.

8           Said committee shall report to the General Court the results of its investigation and study  
9 and its recommendations, if any, together with drafts of legislation necessary to carry such
