In the Year Two Thousand Thirteen

An Act improving access to rehabilitation counseling.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 22 of Chapter 32A of the General Laws, as appearing in the 2008
2 Official Edition, is hereby amended by striking the final paragraph and inserting in place thereof
3 the following paragraph:—

4 For the purposes of this section, “licensed mental health professional” shall mean a
5 licensed physician who specializes in the practice of psychiatry, a licensed psychologist, a
6 licensed independent clinical social worker, a licensed mental health counselor, a licensed nurse
7 mental health clinical specialist, or a licensed rehabilitation counselor.

8 SECTION 2. Section 47B of Chapter 175 of the General Laws, as appearing in the 2008
9 Official Edition, is hereby amended by striking the second paragraph in subsection (i) and
10 inserting in place thereof the following paragraph:—

11 For the purposes of this section, “licensed mental health professional” shall mean a
12 licensed physician who specializes in the practice of psychiatry, a licensed psychologist, a
13 licensed independent clinical social worker, a licensed mental health counselor, a licensed nurse
14 mental health clinical specialist, or a licensed rehabilitation counselor.
