An Act relative to the Max Ulin rink.

*Whereas*, The deferred operation of this act would tend to defeat its purpose, which is to authorize the lease of the Max Ulin Skating Rink in the town of Milton,, therefore, it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           (a) Notwithstanding sections 40E to 40K, inclusive, and sections 52 to 55, inclusive, of  
2 chapter 7 of the General Laws, or any other general or special law to the contrary and using the  
3 competitive proposal processes that the division of capital asset management and maintenance  
4 considers necessary or appropriate, the division of capital asset management and maintenance, in  
5 consultation with the department of conservation and recreation, may enter into a lease and other  
6 agreements, for a term not to exceed 25 years with persons or entities to provide for the  
7 continued use, operation, maintenance, repair and improvement of the Max Ulin Skating Rink,  
8 together with the land and appurtenances associated with the that rink.

9           (b) The failure of the town to apply for prequalification, as set forth below, shall not  
10 prohibit the town from bidding under this act.

11           (c) Before the division of capital asset management and maintenance, in consultation  
12 with the department of conservation and recreation, sends out a request for proposals under this  
13 act, the division shall hold open a prequalification period of not fewer than 30 days for the town

14 of Milton and nonprofit organizations located within the town to bid on the rink. The town or  
15 nonprofit organization that desires to lease the rink under this act may submit materials for  
16 prequalification. The prequalification determination may consider, but shall not be limited to  
17 considering, the town's or nonprofit organization's ability to finance the capital improvements  
18 determined to be necessary at the rink by the division and the ability to manage, operate,  
19 maintain, repair and improve the rink, together with the land and appurtenances associated with  
20 the rink. The division, in consultation with the department, shall determine whether the town or  
21 nonprofit organization is prequalified within 15 days after the end of the prequalification period.  
22 If the town or nonprofit organization is determined to be prequalified, then the town or non-profit  
23 organization shall be awarded the lease for the Max Ulin Skating Rink under the terms and  
24 conditions set forth in this act; provided, however, that only 1 lease shall be awarded based on  
25 preference as described in subsection (d).

26 (d)(1) Preference shall be given to the town of Milton.

27 (2) If the town and a nonprofit organization are determined to be prequalified, the town  
28 shall be awarded the lease.

29 (3) If more than 1 nonprofit organization is determined to be prequalified, the department  
30 may choose to which nonprofit the lease for the rink shall be awarded.

31 (4) The town or a nonprofit organization awarded the lease under this act shall pay the  
32 sum of \$1.00 as consideration for the lease, subject to the required capital improvements,  
33 performance specifications and other prequalification requirements and terms of the division and  
34 submitted proposal. The length of the lease shall be determined between the division and the  
35 town or nonprofit organization.

36 (e) The lease and other agreements shall be on terms acceptable to the commissioner of  
37 capital asset management and maintenance, after consultation with the commissioner of  
38 conservation and recreation and, notwithstanding the provisions of any general or special law to  
39 the contrary, shall provide for the lessees to operate, manage, improve, repair and maintain the  
40 properties and to undertake any initial capital improvements that the commissioner of capital  
41 asset management and maintenance determines necessary due to the structural condition of the  
42 property. Leases or other agreements requiring improvements to be made to the property may  
43 include a description of the initially required improvements and performance specifications. Ice  
44 time at the rink shall be allocated to user groups in the following order of priority: (i) general  
45 public skating; (ii) nonprofit youth groups; (iii) high school hockey; (iv) for-profit youth groups;  
46 and (v) adult organizations or informal groups. Ice time shall be allocated at the discretion of the  
47 operator, but general public skating shall be booked, in 2-hour contiguous blocks at a minimum  
48 of 12 hours per week, with a range of times and days which reasonably allows for public skaters  
49 of all ages to participate in some public skating sessions. Every effort shall be made to balance  
50 the ice allocation needs of long-established youth organizations and newly-formed youth

51 organizations in a manner that provides equal opportunity and equal access for youths of each  
52 gender. Consideration received from the lease or other agreements for the Max Ulin Skating  
53 Rink in Milton shall be payable to the department of conservation and recreation for deposit into  
54 the Blue Hills Reservation Trust Fund in accordance with section 34C of chapter 92 of the  
55 General Laws. The lessees shall bear the costs considered necessary or appropriate by the  
56 commissioner of conservation and recreation for the transactions including, without limitation,  
57 costs for legal work, surveys, title and the preparation of plans and specifications.

58 (f) The name of the Max Ulin Skating Rink shall not be altered or changed under a lease  
59 or other agreement under this act.

60 (g) No general or special law, rule or regulation relating to the advertising, bidding or  
61 award of contracts, to the procurement of services or to the construction and design of  
62 improvements shall be applicable to a selected offeror which is awarded a contract under this act,  
63 except as provided in this act.
