2 Official Edition, is hereby amended by striking out, in lines 30, 32 and 33, the figure “17” and  
3 inserting in place thereof, in each instance, the following figure:- 18.

4           SECTION 2. Section 20 of chapter 31 of the General Laws, as so appearing, is hereby  
5 amended by striking out, in line 10, the word “seventeen” and inserting in place thereof the  
6 following figure:- 18.

7           SECTION 3. Section 24 of chapter 37 of the General Laws, as so appearing, is hereby  
8 amended by striking out, in line 14, the word “seventeen” and inserting in place thereof the  
9 following figure:- 18.

10          SECTION 4. Section 32H of chapter 94C of the General Laws, as so appearing, is hereby  
11 amended by striking out, in lines 31 and 33, the figure “17” and inserting in place thereof, in  
12 each instance, the following figure:- 18.

14 striking out, in line 6, the word “seventeen” and inserting in place thereof the following figure:-

16          SECTION 6. Section 36 of said chapter 94C, as so appearing, is hereby amended by  
17 striking out, in line 6, the words “ his seventeenth” and inserting in place thereof the following  
18 words:- the child’s eighteenth.

19          SECTION 7. Section 52 of chapter 119 of the General Laws, as so appearing, is hereby  
20 amended by striking out, in line 5 and 14, the word “seventeen” and inserting in place thereof, in  
21 each instance, the following figure:- 18.

22 SECTION 8. Section 54 of said chapter 119, as so appearing, is hereby amended by  
23 striking out, in lines 2 and 20, the word “seventeen” and inserting in place thereof, in each  
24 instance, the following figure:- 18.

25 SECTION 9. Section 58 of said chapter 119, as so appearing, is hereby amended by  
26 striking out, in lines 9 and 10, the words “eighteen or age nineteen in the case of a child whose  
27 case is disposed of after he has attained his eighteenth birthday” and inserting in place thereof the  
28 following words:- 18, or age 19 in the case of a child whose case is disposed of after the child  
29 has attained the child’s eighteenth birthday or age 20 in the case of a child whose case is  
30 disposed of after the child has attained the child’s nineteenth birthday.

31 SECTION 10. Said section 58 of said chapter 119, as so appearing, is hereby further  
32 amended by striking out, in lines 24 to 26, inclusive, the words “eighteen, or nineteen in the case  
33 of a child whose case is disposed of after he has attained his eighteenth birthday” and inserting in  
34 place thereof the following words:- 18, the age of 19 in the case of a child whose case is disposed  
35 of after he has attained his eighteenth birthday or the age of 20 in the case of a child whose case  
36 is disposed of after the child has attained the child’s nineteenth birthday.

83 birthday and all provisions and rights applicable to a child under the age of 18 shall apply to the  
84 child.
