An Act relative to increasing killed-in-line-of-duty benefits for public safety employees.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1            Subsection (c). Section 100A of Chapter 32 of the General Laws, as appearing in the  
2            official 2012 edition, is hereby amended by striking the word “\$100,000” in line 8 and inserting  
3            in place thereof :- \$250,000.

4            Subsection (d). Section 100A of Chapter 32 of the General Laws, as appearing in the  
5            official 2012 edition, is hereby amended by striking the word “\$100,000” in line 21 and inserting  
6            in place thereof :- \$250,000.

7            Subsection (e). Section 100A of Chapter 32 of the General Laws, as appearing in the  
8            official 2012 edition, is hereby amended by striking the word “\$100,000” in line 31 and inserting  
9            in place thereof :- \$250,000.

10           Subsection (f). Section 100A of Chapter 32 of the General Laws, as appearing in the  
11           official 2012 edition, is hereby amended by striking the word “\$100,000” in line 32 and inserting  
12           in place thereof :- \$250,000.
