- Whereas, the greatest asset of the Commonwealth of Massachusetts is its people;
- 4 Whereas, the Commonwealth of Massachusetts is comprised of multicultural, multiethnic
- 5 and multiracial citizens;
- Whereas, friendship, collegiality, civility, respect, and kindness are commonly shared
- 7 ideals of the collective citizenry of the Commonwealth of Massachusetts;
- 8 Whereas, the Towards E Pluribus Unum Initiative has invited communities across the
- 9 United States of America to join in introspection and reflection on the beauty and richness of the
- diverse peoples of this great nation while reaching out with a spirit of amity toward one another
- annually on the second Sunday in June;

15	(1) Proclaims the 2nd Sunday in June annually be designated as Massachusetts Race

17	(2) Supports the goals and ideals of Race Amity Day in the Commonwealth of

19	(3) Encourages all citizens of the Commonwealth of Massachusetts to join in activities in
20	support of the goals and ideals of Race Amity Day
21	(4) Authorizes and issues this Resolution calling on the people of the Commonwealth of
22	Massachusetts to observe Massachusetts Race Amity Day with appropriate programs and
23	activities.
