**In the One Hundred and Eighty-Ninth General Court  
(2015-2016)**

An Act relative to compensation for family caregivers.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 118E of the General Laws is hereby amended by inserting after section 9F, as  
2 appearing in the 2012 Official Edition, the following section:-

3 Section 9G. (a) As used in this section, the following words shall, unless the context  
4 clearly requires otherwise, have the following meanings:-

5 “Eligible person”, a resident determined by the division to be clinically eligible for long-  
6 term care services pursuant to section 9.

7 “Family caregiver”, a person who is a family member of an eligible person and who  
8 provides medical or supervisory care to the eligible person pursuant to this section.

9 “Family member”, a person who is related by consanguinity, legal custody, marriage or a  
10 person with whom a family caregiver lives in a familial relationship.

11 (b) Notwithstanding any general or special law to the contrary, the division shall  
12 establish, subject to appropriation, the availability of federal financial participation and all  
13 required federal approvals and agreements, a program to provide monthly compensation to  
14 family caregivers for providing medical and supervisory care of an eligible person, to be known  
15 as the long-term family care program. A family caregiver may not receive compensation  
16 pursuant to the long-term family care program if the eligible person resides in a long-term health  
17 care or nursing facility.

18 (c) The division shall ensure that enrollment in the program is voluntary. All eligible  
19 persons enrolling in the program have the right to disenroll from the program in any month upon  
20 submitting a notice of disenrollment to the division or contracted entity. Disenrollment notices  
21 received by the division or contracted entity by the twentieth day of the month shall be effective  
22 on the first day of the following month.

23 (d) The division shall educate consumers and their families as to their enrollment choices  
24 under the long-term family care program.

25 (e) The division shall promulgate any rules or regulations necessary to implement this  
26 section.
