Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Section 3 Chapter 70 of the General Laws, as appearing in the 2012 Official
2 Edition, is hereby amended by inserting, in line 11, after the word “section 2.” the following:-
- 3 Current employee and retiree health care costs shall be included in the calculation of the
4 foundation budget for each school district.
