An Act authorizing the town of Chelmsford to hold licenses for the sale of all alcoholic beverages to be drunk on the premises.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. (a) For the purpose of operating the Chelmsford Center for the Arts located
2 at 1A North Road in the town of Chelmsford and the Chelmsford Community Center located at
3 31 Princeton Street in the town of Chelmsford, the town may hold licenses for the sale of all
4 alcoholic beverages to be drunk on the premises.

5 (b) Notwithstanding the provisions of section 17 of chapter 138 of the General Laws, the
6 licensing authority in the Town of Chelmsford may issue to the Town of Chelmsford a license to
7 sell all alcoholic beverages to be drunk on the premises located at 1A North Road in said town
8 under the provisions of section 12 of said chapter 138. Said license shall be subject to all of the
9 provisions of said chapter 138 except said section 17.

10 (c) Notwithstanding the provisions of section 17 of chapter 138 of the General Laws, the
11 licensing authority in the Town of Chelmsford may issue to the Town of Chelmsford a license to
12 sell all alcoholic beverages to be drunk on the premises located at 31 Princeton Street in said
13 town under the provisions of section 12 of said chapter 138. Said license shall be subject to all
14 of the provisions of said chapter 138 except said section 17.

15 (d) Once issued, the licensing authority shall not approve the transfer of the licenses
16 issued under this section to any other location or to any other entity.

17 SECTION 2. Notwithstanding section 58 of chapter 44 of the General Laws, the town of
18 Chelmsford may pay bills incurred for the purchase of all alcoholic beverages acquired for use
19 with the license authorized in section 1.

20 SECTION 3. This act shall take effect upon its passage.
