An Act making appropriations for the fiscal year 2018 to provide for supplementing certain existing appropriations and for certain other activities and projects.

*Whereas*, The deferred operation of this act would tend to defeat its purpose, which is to make supplemental appropriations for fiscal year 2018 and to make certain changes in law, each of which is immediately necessary to carry out those appropriations or to accomplish other important public purposes, therefore, it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. To provide for supplementing certain items in the general appropriation  
2 act and other appropriation acts for fiscal year 2018, the sums set forth in section 2A are hereby  
3 appropriated from the General Fund unless specifically designated otherwise in this act or in  
4 those appropriation acts, for the several purposes and subject to the conditions specified in this  
5 act or in those appropriation acts, and subject to the laws regulating the disbursement of public  
6 funds for the fiscal year ending June 30, 2018. These sums shall be in addition to any amounts  
7 previously appropriated and made available for the purposes of those items.

8           SECTION 2A. To provide for certain unanticipated obligations of the commonwealth,  
9 to provide for an alteration of purpose for current appropriations, and to meet certain  
10 requirements of law, the sums set forth in this section are hereby appropriated from the General

11 Fund unless specifically designated otherwise in this section, for the several purposes and subject  
12 to the conditions specified in this section, and subject to the laws regulating the disbursement of  
13 public funds for the fiscal year ending June 30, 2018. These sums shall be in addition to any  
14 amounts previously appropriated and made available for the purposes of those items.

19 SECTION 3. Subsection (g) of section 20 of chapter 121 of the acts of 2016, is hereby  
20 amended by striking out the words, “December 30, 2017” and inserting in place thereof, the  
21 following words:- December 1, 2018.

22 SECTION 4. Upon the deposit of sufficient funds in the Marijuana Regulation Fund  
23 established pursuant to section 14 of chapter 94G of the General Laws, the Massachusetts  
24 cannabis control commission established pursuant to section 76 of chapter 10 of the General  
25 Laws, shall transfer the same amounts as appropriated in item 1070-0840 and item 1599-0840 in  
26 fiscal year 2017 and fiscal year 2018, to the General Fund of the commonwealth established  
27 pursuant to section 2 of chapter 29 of the General Laws.
