An Act providing certain state employees sick leave for COVID-19 related absences.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           Notwithstanding any general or special law to the contrary, any employee of the  
2   commonwealth who is absent from work due to COVID-19 infection, quarantine or isolation as  
3   directed by a physician or authorized public health authority and does not have sufficient earned  
4   sick leave time for the absence, shall be granted sufficient sick leave time to ensure any absence  
5   from work due to COVID-19 infection, quarantine or isolation is paid.

6           This act will be in effect until 60 days after the state of emergency is lifted.
