**In the One Hundred and Ninety-First General Court  
(2019-2020)**

An Act relative to a Massachusetts broadband competitive marketplace study.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           Section 1. (a) There shall be a special commission to examine the state of the advanced  
2 telecommunications broadband industry in Massachusetts, including fiber-to-the-premises, cable,  
3 wireless, and landline technologies with the goal of recommending a rational and balanced  
4 approach to oversight of the interconnected telecommunications network of the future and ensure  
5 the Commonwealth's consumers, both residents and businesses, as well as Competitive Local  
6 Exchange Carriers (CLECs) have access to reliable and competitive broadband network.

7           (b) The commission shall review: (i) status of competition and pricing for broadband  
8 communications services and networks; (ii) current and future consumer expectations; (iii)  
9 assessment of national and international approaches to ensuring core public interest principles

10 and robust communications capabilities are maintained; (iv) reliability, resiliency and  
11 interoperability of networks; (v) technology types and speeds available across the state; (vi)  
12 access and underservice issues; (vii) Overview of the E-Rate, Rural Health, and FirstNet Federal  
13 and other broadband programs in the Commonwealth; and (viii) comparative analysis of results  
14 matching census data across the Commonwealth.

15 (c) The special commission shall consist of the following members or their designees: the  
16 Commissioner of the department of telecommunications and cable, who shall serve as a co-chair;  
17 the senate and house chairmen of the Joint Committee on Telecommunication, Utilities and  
18 Energy who shall serve as the other co-chairs; (1) representative of the Massachusetts Attorney  
19 General Consumer Advocacy & Response Division (1) representative of the Massachusetts  
20 Communications Supervisors Association.; (1) representative of the Massachusetts Broadband  
21 Institute; (1) representative of the Massachusetts Municipal Association, Inc.; (1) representative  
22 of the Massachusetts Technology Leadership Council ; (1) representative designated by the  
23 President of the AFL-CIO from a Massachusetts telecommunications union and (2) members  
24 who shall be appointed by the governor, (1) of whom shall be a professor from with research in  
25 telecommunication policy, and (1) of whom shall be a senior executive/manager from a  
26 Competitive Local Exchange Carrier (CLEC).

27 (d) The special commission shall file an initial report of its recommendations and drafts  
28 of proposed broadband legislation or regulations, if any, on subsection (b) with the clerks of the  
29 house of representatives and the senate, the President of the Senate, The Speaker of the House of  
30 Representatives, the Governor and the chairs of the house and senate committees on ways and  
31 means not later than December 31, 2017. The special commission shall file a final report  
32 providing a full report regarding said subsection (b) not later than March 1, 2018.
