An Act protecting ratepayers from gas pipeline expansion costs.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 94A of chapter 164 of the General Laws is hereby amended by
2 adding, at the end thereof the following:-

3 Notwithstanding anything set forth herein, the department shall not approve any contract
4 for the purchase of gas, gas pipeline capacity or liquefied gas storage where any contract costs
5 would be recoverable from the ratepayers, if such contract requires any construction or
6 expansion of interstate gas infrastructure.
