# JOURNAL OF THE HOUSE.

Wednesday, November 4, 2020.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

## *Order.*

The engrossed Bill providing survivor benefits to Ava Roy, the daughter of fallen firefighter Christopher Roy (see House, No. 4826) (which originated in the House), having been certified by the Clerk to be rightly and truly prepared for final passage, was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

By Mr. Michlewitz of Boston, for the committee on Ways and Means, that the Bill authorizing the Division of Capital Asset Management and Maintenance to grant a drainage easement, and amending a permanent right of way easement, to the city of Marlborough (House, No. 3982), ought to pass with an amendment substituting therefor a bill with the same title (House, No. 4899). Referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.
