### JOURNAL OF THE SENATE.

Thursday, January 7, 2016.

Met at eighteen minutes past eleven o'clock A.M. (Mr. DiDomenico in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

*Matters Taken Out of the Orders of the Day.*

There being no objection, the following matters were taken out of the Orders of the Day and considered as follows:

The Senate Bill relative to affordable housing in East Boston (Senate, No. 1966),-- **was read a second time, ordered to a third reading, read a third time and passed to be engrossed, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act further regulating certain affordable housing in the East Boston section of the city of Boston."**

**Sent to the House for concurrence.**

The House Bill further regulating the authority of the town manager in the town of Duxbury to negotiate and execute certain contracts (House, No. 3343, amended) (its title having been changed by the committee on Bills in the Third Reading),-- **was read a third time and passed to be engrossed, in concurrence.**

*Reports of Committees.*

By Mr. Montigny, for the committee on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Bruce E. Tarr, William N. Brownsberger, James Arciero, Shawn Dooley and other members of the General Court for legislation relative to safe driving and open containers.

**The rules were suspended, on motion of Mr. Tarr, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on the Judiciary.**

Haddad for legislation to establish a sick leave bank for Tina Jennings, an employee of the Department of Developmental Services.  
**The rules were suspended, on motion of Mr. Tarr, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Public Service. Severally sent to the House for concurrence.**

*Moment of Silence.*

At the request of the Chair (Mr. DiDomenico), the members, guests and staff stood in a moment of silence and reflection to the memory of Michael "Mike" Mullane.

*Adjournment in Memory of Michael "Mike" Mullane.*

The Senator from Middlesex, Mr. Donnelly, the Senator from Norfolk and Plymouth, Mr. Keenan, and the Senator from Essex and Middlesex, Mr. Tarr, moved that when the Senate adjourns today, it adjourn in memory of Michael "Mike" Mullane of Quincy and Boston Fire Department Engine 21.

Mike was born and raised in Dorchester. He graduated from Boston Technical High School before joining the Navy. After returning home, Mike joined the Boston Fire Department where he served for 43 years, assigned to Engine 21.

Mike fought relentlessly for the middle class and was a union stalwart, first serving as president of Local 718 and for the last 32 years as vice president of the International Association of Fire Fighters. He also served as a founding member of the Mass Fallen Firefighters Memorial Committee.

Mike was a constant fixture at Florian Hall and the type of guy who would give you the shirt off his back. He knew everyone and was always willing to help firefighters and their families.

Family meant everything to Mike. He was a continual presence and a source of inspiration for all his nieces and nephews. Their children, the next generation, knew exactly how to find Uncle Mike as soon as they opened the door at Florian Hall. He loved them and they loved him.

Mike was strong and courageous in the face of adversity, none more evident than in the last 6 weeks of his life. He died on January 1, of complications from surgery, with his loving family at his bedside.

Mike is survived by his best friend, the love of his life, Elaine Malone of South Boston, her sons Sean and his wife Stacy, and Scott and his son Nolan of Pensacola, Florida and their son Jack of Lucedale, Mississippi.

Mike was preceded in death by his parents William (BPD Detective Ret.) and Laurentine (Waggett) Mullane and his brother Neal Mullane, Sr. (Lt. BFD E21 Ret.) and his wife Elaine.

Mike was the devoted brother of William "Bo" Mullane (BPD Lt. Detective Ret.) and his wife Patricia of South Boston, Janice "Sissy" Mullane (BTD Ret.) of Quincy, Jacqueline Miner and her husband Arthur of Hanson, and Ann Diodati of Ipswich.

He is also survived by many loving nieces and nephews and great-nieces and great-nephews.

Mike touched many hearts during his life. He was liked by those who met him and loved by all those who were fortunate enough to know him. He will be greatly missed but never forgotten.
