There being no objection, the rules were suspended, on motion of Mr. deMacedo, and the bill was a read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.

By Ms. Spilka, for the committee on Ways and Means, that the House Bill creating a sick leave bank for Robert Paterwic (House, No. 48),-- ought to pass, with an amendment striking out, in line 3, the following words:- “employee of the commonwealth who is related to Robert Paterwic and any” ; and by striking out the title and inserting in place thereof the following title:- “An Act establishing a sick leave bank for Robert Paterwic, an employee of the Department of Industrial Accidents”.

There being no objection, the rules were suspended, on motion of Mr. deMacedo, and the bill was a read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence, with the amendment. Sent to the House for concurrence in the amendment.

Salmon, Sr., second husband Edgar Breault, her son Timothy Salmon of Newburyport and will be forever loved and dearly missed by her entire extended family, most especially her sons Daniel J. and his wife Dorothy of Sutton, Michael and his wife Barbara of Whitinsville, Robert and his wife Flora of China, Mark of Sutton, her daughter-in-law Christie Salmon and her 14 grandchildren and 17 great-grandchildren.
