JOURNAL OF THE SENATE.

Monday, April 6, 2015.

Met at thirteen minutes past eleven o'clock A.M. (Mr. Petrucci in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Petrucci), members, guests and staff then recited the pledge of allegiance to the flag.

Communication.

Communication from the Honorable Patricia D. Jehlen, in compliance with Massachusetts General Laws Chapter 268A (received in the Office of the Clerk of the Senate on Thursday, April 2, 2015, at twenty minutes before five o'clock P.M.),-- **was placed on file.**

Report.

Report of the Department of Public Health (pursuant to Section 2K K K K of Chapter 29 of the General Laws) submitting its annual report regarding implementation of the Medical Marijuana Trust Fund (received April 6, 2015),-- **was placed on file.**

Petition.

Mr. McGee presented a petition (accompanied by bill, Senate, No. 40) of Thomas M. McGee, Brendan P. Crighton, Lori A. Ehrlich, Robert F. Fennell and others (with the approval of the mayor and city council) for legislation to authorize the city of Lynn to grant an additional liquor license for the sale of wine and malt beverages not to be drunk on the premises [Local approval received];

Report of a Committee.

Mr. Kennedy, for the committee on Consumer Protection and Professional Licensure, on the Communication from the Massachusetts Gaming Commission (under the provisions of Section 9B of Chapter 128A of the General Laws) submitting proposed regulations governing supplemental licensure procedures for 205 CMR 14.00 (printed in Senate, No. 17),-- **reported that the regulations and conditions are consistent with the statutory provisions under which they were promulgated and further recommended that the same be placed on file.**

A Bill establishing a sick leave bank for John Morrill, an employee of the Attleboro district court (House, No. 1368,-- on petition),-- **was read and, under Senate Rule 27, referred to the committee on Ways and Means.**

Lesser and Lewis, Ms. O'Connor Ives, Ms. Spilka and Mr. Wolf) "commending the Kfar Vradim Youth Band on its performance at the Massachusetts State House."

PAPERS FROM THE HOUSE

Emergency Preamble Adopted.

An engrossed Bill providing for the financing of certain improvements to municipal roads and bridges (see House Bill, printed in House, No. 3187, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- **was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.**

The bill was signed by the Acting President (Mr. Petrucci) and sent to the House for enactment.

Engrossed Bill.

An engrossed Bill relative to the town of Reading home rule charter (see House, No. 63) (which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and signed by the Acting President (Mr. Petrucci) and laid before the Governor for his approbation.

Reports of Committees.

By Mr. Montigny, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Thomas P. Kennedy and Michael D. Brady for legislation to establish a sick leave bank for Marlo Carter, an employee of the Department of Correction.

The rules were suspended, on motion of Mr. Tarr, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Public Service.

By Mr. Montigny, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of James E. Timilty for legislation to establish a sick leave bank for Barbara Jean Daniels, an employee of the Department of Developmental Services.

The rules were suspended, on motion of Mr. Tarr, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Public Service. Severally sent to the House for concurrence.

Adjournment in Memory of David J. Brosnan.

The Senator from Essex and Middlesex, Mr. Tarr, requested that when the Senate adjourns today, it adjourn in memory of David J. Brosnan.

David J. Brosnan died February 26, 2015, at the age of 74. Mr. Brosnan was a Retired Major of the Massachusetts State Police. He was born in Gloucester on December 7, 1940 to the late Daniel and Janet Brosnan.

Before beginning his distinguished law enforcement career, Mr. Brosnan attended Gloucester High School, graduating in 1959. He earned his bachelor's degree from New Hampshire College and served in the United States Air Force from 1959 to 1963. As a member of the Air Force, he served as a radar operator with the 861st Radar Squadron.

Mr. Brosnan became a Massachusetts State Trooper on August 30, 1964 and served for 25 years. He was well respected by his fellow troopers and was a highly decorated veteran on the force when he retired on July 1, 1989. Despite retiring, Mr. Brosnan continued to work part time as a Security Advisor for Gillette and with the United States Marshalls Office in the Federal Courthouse in Boston.

In his free time, Mr. Brosnan volunteered as a representative for the National Greyhound Association advocating for the protection of greyhounds throughout Massachusetts. He is survived by his wife, Sandra, his son, Michael Brosnan and wife, Billie Jo; his daughter, Jill Elwell and her husband Stephen, and a dozen grandchildren and great grandchildren. His dedication to protecting the Commonwealth will not soon be forgotten.
