JOURNAL OF THE SENATE.

Wednesday, April 8, 2015.

Met at four minutes past two o'clock P.M. (Mr. Pacheco in the Chair).

Distinguished Guests.

Mr. DiDomenico in the Chair, the same Senator then introduced, in the rear of the Chamber, the Everett Pop Warner National Championship Football Team. The team consisted of 7th and 8th grade Everett students who were recognized for outscoring their opponents 553-41 and completing the season with a 17-0 record. The Senate applauded their accomplishments and they withdrew from the Chamber. The team was accompanied by Head Coach Dennis Willcox, Coaches Rick Pulsifer, John Romboli, Victor Ruiz, Joey White, Carol Manuel, Chris Davidson, Danielle Nadeau and team moms Kelly Wilcox and Missy Raduazzo. They were also guests of Representative McGonagle.

Communication.

Petition (accompanied by bill, House, No. 3337) of Benjamin Swan and Domenic J Sarno, Mayor (with the approval of the mayor and city council) that the city of Springfield be exempt from certain provisions of municipal contracts law;

To the committee on State Administration and Regulatory Oversight.

Report of the committee on Financial Services asking to be discharged from further consideration of the petition (accompanied by bill, House, No. 933) of David M. Rogers, Paul W. Mark and others for a legislative amendment to the Constitution to declare rights afforded to the human inhabitants of the Commonwealth are not applicable to corporations, limited liability companies or any other corporate entities,-- **and recommending that the same be referred to the committee on The Judiciary,-- was considered forthwith, under Senate Rule 36, and accepted, in concurrence.**

There being no objection, at five minutes past two o'clock P.M., the Chair (Mr. Pacheco) declared a recess subject to the call of the Chair; and, at seven minutes past four o'clock P.M., the Senate reassembled, the President in the Chair.

At eight minutes past four o'clock P.M., Mr. Tarr doubted the presence of a quorum.

The President, having determined that a quorum was not in attendance, then directed the Sergeant-at-Arms to secure the presence of a quorum.

Subsequently, at nine minutes past four o'clock P.M., a quorum was declared present.

Mr. DiDomenico in the Chair, the Chair then led the President, members, guests and staff in the recitation of the pledge of allegiance to the flag.

Engrossed Bill—State Loan.

An engrossed Bill providing for the financing of certain improvements to municipal roads and bridges (see House Bill, printed in No. 3187, amended) (which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was put upon its final passage; and, this being a bill providing for the borrowing of money, in accordance with the provisions of Section 3 of Article LXII of the Amendments to the Constitution, the question on passing it to be enacted was determined by a call of the yeas and nays, at seventeen minutes past four o'clock P.M., as follows to wit (*yeas 38 - nays 0*) **[Yeas and Nays No. 15]:**

Adjourn In Memory of Frank A. Zinck, Jr.

The Senator from Middlesex, Mr. Lewis, moved that when the Senate adjourns today, it do so in memory of Frank A. Zinck, Jr.

Chief Frank A. Zinck, Jr. was born on January 19, 1942 to Frank Sr. and Eva Zinck. Frank was a lifelong resident of Melrose and attended the Melrose Public Schools graduating Melrose High School in 1960.

Frank's passion has always been firefighting, even as a young boy when he would hang out at Engine 3's quarters hoping to "spark" a fire. Frank would assist the companies when they had brush fires in hopes that one day that he would become a "Jake". Frank's passion became a reality in 1963 when he was appointed to the Melrose Fire Department. He was promoted to Fire Lieutenant in 1982 and Fire Captain in 1988. In 1996 Frank was instrumental in the creation of the Fire Prevention Office and became the first Fire Prevention Captain in the history of the Melrose Fire Department. He was appointed Chief of Department in 1999 until his retirement in 2002.

Even after his retirement, Frank would stop by the various fire stations to say hello, and if you happen to come upon a fire in Melrose, if he wasn't in Florida or Maine, chances are you would see Frank standing by with his scanner. Frank will be remembered as a kind, compassionate, and caring man always laughing and upbeat. He is survived by his wife, son, stepchildren, and many grandchildren.
