Monday, June 6, 2016.

Met at nine minutes past eleven o'clock A.M. (Mr. Boncore in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Boncore), members, guests and staff then recited the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the Chair (Mr. Boncore) handed the gavel to Mr. Tarr for the purpose of an introduction. Mr. Tarr then introduced and invited to the Rostrum Her Honor the Lieutenant-Governor, Karyn E. Polito. The Lieutenant-Governor briefly addressed the Senate and guests on the importance that scouting has on the Commonwealth and the impact it has on our everyday lives.

There being no objection, the Chair (Mr. Tarr) then introduced and invited to the Rostrum, Eagle Scout Justin St. Louis from Troop 7 in Lowell, Webelos Cub Scout Garreth Gray, Police Explorer Melony Ellis, Sea Scout Emily Newell, Venturer Michelle Merritt and 1st Class Zachariah Morris. The group was accompanied by Director of Field and Service Jonathan Pleva and many different scouting groups from Massachusetts. Eagle Scout Justin St. Louis briefly addressed the Senate on the accomplishments of scouting in Massachusetts and the many benefits boys and girls received through scouting.
