### JOURNAL OF THE SENATE.

*Monday, June 15, 2015.*

Met at three minutes past eleven o'clock A.M. (Mr. Keenan in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Keenan), members, guests and staff then recited the pledge of allegiance to the flag.

#### *Report.*

A report of the Executive Office of Health and Human Services (pursuant to Section 15 of Chapter 118I of the General Laws) submitting its Health Information Technology Council Annual Report (received June 12, 2015),-- **was placed on file.**

#### *Reports of Committees.*

By Mr. Wolf, for the committee on Labor and Workforce Development, , on petition, a Bill relative to fairness in worker's compensation disfigurement benefits (Senate, No. 968);

By the same Senator, for the same committee, on petition, a Bill relative to permissible topics of collective bargaining (Senate, No. 972);

By the same Senator, for the same committee, on petition, a Bill relative to the penalty for failure to provide workers' compensation insurance (Senate, No. 990); and

By the same Senator, for the same committee, on petition, a Bill relative to workers compensation insurance (Senate, No. 1021);

#### *Report of a Committee.*

Mr. Montigny, for the committee on Rules, reported that the following matter be placed in the Orders of the Day for the next session:

The Senate Bill relative to Essex Tech (Senate, No. 1919).

**There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time.**

Pending the question on passing the bill to be engrossed, Ms. Lovely presented an amendment inserting before the enacting clause the following emergency preamble:-

“Whereas, the deferred operation of this act would tend to defeat its purpose, which is to delay implementation of a previous law, therefore, it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.”

**The amendment was adopted.**

**The bill (Senate, No. 1919, amended) was then ordered to a third reading, read a third time and passed to be engrossed. Sent to the House for concurrence.**

#### *Matter Taken Out of the Orders of the Day.*

There being no objection, the following matter was taken out of the Orders of the Day and considered as follows:

The Senate Bill amending the town charter for the town of Randolph (Senate, No. 24),-- **was read a third time.**

Pending the question on passing the bill to be engrossed, Mr. Joyce presented an amendment substituting a new draft entitled “An Act authorizing the amendment of the charter of the town of Randolph” (Senate, No. 1942).

**The amendment was adopted.**

**The bill (Senate, No. 1942) was then passed to be engrossed.**

By Ms. Spilka, for the committee on Ways and Means, that the House Bill establishing a sick leave bank for Thomas J. Doucette, an employee of the Department of Correction (House, No. 3358),-- **ought to pass.**  
**There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.**
