JOURNAL OF THE SENATE.

Monday, July 13, 2015.

Met at seven minutes past eleven o'clock A.M. (Ms. O'Connor Ives in the Chair).

The Chair (Ms. O'Connor Ives), members, guests and staff then recited the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the Chair (Ms. O'Connor Ives) handed the gavel to Mr. Tarr for the purpose of an introduction. Mr. Tarr then introduced, in the rear of the Chamber, Veterans Service Director of the Eastern Essex District, Karen Tyler. She was accompanied by Georgia Gadboro, an assistant to the Veterans Service Office, and Douglas W. Dawes, a Georgetown Selectman and Commander of the Rene H. Gagnon American Legion Post #211. They were visiting the State House to accept an adjournment order in memory of Veteran Terrance Hart of Georgetown who passed away on May 1, 2014. The Senate welcomed them with applause and they withdrew from the Chamber.

Order Adopted.

Mr. Donnelly offered the following order, to wit:

Ordered, That by the authority of article IV of section II of chapter I of the Constitution, the Senate declares that, by reason of the death of Thomas P. Kennedy as senator from the Second Plymouth and Bristol district, the office of senator from the Second Plymouth and Bristol district is vacant. By the authority of article XXIV of the Amendments to the Constitution, the Senate directs the president of the Senate to issue a precept setting forth November 3, 2015, as the day for holding an election to fill the vacancy in the Second Plymouth and Bristol district, comprising the city of Brockton and the towns of East Bridgewater, precincts 1 to 3, inclusive, Halifax, Hanover, Hanson, Plympton and Whitman, all in the county of Plymouth; and the town of Easton, precincts 1 and 2, in the county of Bristol.

Under the rules, referred to the committee on Rules.

Subsequently, Mr. Montigny, for the said committee, reported, recommending that the order ought to be adopted.

The rules were suspended, on motion of Mr. Brownsberger, and the order was considered forthwith and adopted.

Adjournment in Memory of Thomas W. Wisdom Wigmore.

The Senator from Plymouth and Norfolk, Mr. Hedlund, requested that when the Senate adjourns today, it adjourn in memory of Thomas W. Wisdom Wigmore.

Thomas W. Wisdom Wigmore, also known as Wiggy, age 51, of Cohasset and Hingham, passed away on his most favorite holiday, July 4, 2015, surrounded by family and friends.

Tom was a Commander of the Sons of the American Legion Squadron 118, which he reactivated 27 years ago. He was a past State Commander of Massachusetts Detachment of the Sons of the American Legion as well as a past National Vice Commander, and held many other state and National offices. Tom organized many events in Cohasset, including 9/11 services and veterans services, but he was particularly proud of the Memorial Day service which included The Healing Field, which he founded 9 years ago. In addition, Tom served the town of Cohasset for twenty eight and a half years, working in numerous positions from Assistant Harbormaster, Communication Dispatcher and Supervisor for Police and Fire, to maintenance. He was recently awarded Citizen of the Year 2015.

Tom was the beloved husband of Deirdre (Brady) Wigmore; son of Stephen F. Wigmore and the late Grace Anne (Murphy) Wigmore; brother of Anthony J. Wigmore; nephew of Joan Habbep and husband Ralph, and Mary Stafford and husband Roy; brother-in-law of Clare Brady and friend Nancy Campbell and Karen Pipes and husband Donald; uncle of Kasey Pipes, Carly Rooney and husband Ian and Gianna Schiavo of Cohasset. He is also survived by several cousins.
