An Act relative to the provision of services to the City of Cambridge by the Cambridge Energy Alliance..

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Section 1. As used in this act, the following words shall have the following meanings:

2 “City”, the City of Cambridge.

3 “Corporation”, the Cambridge Energy Alliance, a not-for-profit corporation incorporated  
4 under chapter 180 of the General Laws and created and controlled by the Cambridge Public  
5 Health Commission.

6 “Commission”, the Cambridge Public Health Commission established pursuant to chapter  
7 147 of the acts of 1996.

8 “Department”, the Department of Energy Resources.

9 “Energy conservation projects”, as defined in chapter 25A of the General Laws.

10 “Energy management services”, as defined in chapter 25A of the General Laws.

11 “Municipal Buildings”, buildings and structures owned or operated by the City or any  
12 department thereof, or by the Cambridge Public Health Commission.

13 “Municipal Energy Advisory Services”, one or more of the following services: (i)  
14 providing access to the forward-capacity energy market and similar programs to realize the  
15 benefits of the City’s conservation and clean energy efforts, (ii) providing advice and assistance  
16 in evaluating and documenting measures to reduce energy and water consumption in Municipal  
17 Buildings, including performing energy audits, monitoring energy and water consumption in  
18 Municipal Buildings, and optimizing operating procedures of Municipal Buildings and  
19 installations therein for the purpose of reducing, measuring or controlling energy or water  
20 consumption, (iii) providing advice and assistance to the City in its procurement and  
21 administration of energy management services, and (iv) providing advice and assistance in  
22 identifying, obtaining and administering grants or other funding sources of financing programs  
23 for clean energy and energy and water conservation in the City. The term Municipal Energy  
24 Advisory Services shall also include providing energy management services to the City,  
25 including design services, but shall not include the actual installation or construction of energy  
26 conservation projects in Municipal Buildings.

27 Section 2. Notwithstanding the provisions of chapter 25A, chapter 30B and any other  
28 general or special law relative to public procurement processes to the contrary, the City is hereby  
29 authorized to enter into an agreement, or a series of agreements, with the Corporation for the  
30 provision of Municipal Energy Advisory Services for a maximum contract term in accordance  
31 with section six of this Act. Payments under an agreement for the provision of such services may  
32 be based in whole or in part on any revenues gained due to energy or water conservation or

33 demand reduction measures undertaken with respect to Municipal Buildings for which advisory  
34 services were performed by the Corporation.

35           Section 3. The City will provide to the Department and the Office of the Inspector  
36 General, within ninety (90) calendar days of the close of each applicable fiscal year, a report  
37 detailing any agreements the City has entered into with the Corporation for the provision of  
38 Municipal Energy Advisory Services, which report shall include without limitation: a detailed  
39 schedule of services provided to the City and the compensation payable to the Corporation for  
40 such services; and a certification from the Chief Executive Officer or Treasurer of the  
41 Corporation that the entirety of the revenues and/or carbon credits or similar benefits received on  
42 account of Municipal Energy Advisory Services provided to the City in excess of the costs  
43 necessary to provide such Municipal Energy Advisory Services, including staff and  
44 administrative costs, has been paid or set aside by the Corporation for one or more of the  
45 following purposes: (i) undertaking conservation education for residents and/or businesses in the  
46 City, (ii) promoting energy and water conservation within the City, and/or (iii) subsidizing  
47 energy audits, energy conservation measures or energy conservation projects in low-income  
48 residences in the City or in Municipal Buildings.

49           Section 4. In the event that any agreement between the City and the Corporation for the  
50 provision of Municipal Energy Advisory Services provides for revenues to be paid to the City,  
51 including the proceeds of any forward-capacity energy market credits, the City may establish a  
52 revolving fund and may deposit such revenues into such revolving fund. Monies held in this  
53 revolving fund may be expanded for the purpose of (a) paying for Municipal Energy Advisory  
54 Services, (b) paying the costs of Energy conservation projects or debt service payments for  
55 Energy conservation projects financed with municipal obligations, or (c) reinvesting a portion of

56 such revenues into conservation and clean energy programs in the City, including outreach  
57 services, technical assistance and direct incentives.

58 Section 5. If any provision of this Act or the application of such provision to any person  
59 or circumstance shall be held invalid, the validity of the remainder of the Act and the  
60 applicability of such provision to other persons or circumstances shall not be affected thereby.

61 Section 6. The provision of this Act shall expire ten years following the date of its  
62 passage unless reenacted by the Legislature. The expiration of this Act shall not affect the  
63 validity of any contract executed pursuant to this Act prior to such expiration, and all provisions  
64 of this Act shall continue to apply to said contracts for the remainder of the term of said  
65 contracts.

66 Section 7. The provisions of this Act shall be effective immediately upon passage.
