An Act Establishing A Special Account for the Town of Billerica Water Conservation Fund..

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Notwithstanding the provisions of any general or special law, rule or
2 regulation to the contrary, the town of Billerica is hereby authorized to establish a special
3 account to be known as the Town of Billerica Water Conservation Fund. The purpose of such
4 fund is to provide revenue for the funding of water management and conservation initiatives by
5 the town, including the design, construction and implementation of measures to conserve water
6 and assure the efficient operation of the town's public water supply system and public education
7 relating to water conservation plans and programs, consistent with the Billerica water
8 conservation policy. Such special account shall be maintained by the treasurer of the town of
9 Billerica and may be deposited in a suitable banking institution doing business in the
10 commonwealth or invested by the treasurer as provided herein. Expenditures from said special
11 account shall be made subject to appropriation initiated by the board of selectmen upon the
12 recommendation of the director of public works and the town manager of said town, and
13 approved by a majority vote of the town meeting.

14 SECTION 2. Payments to such account shall be made by applicants for permits to
15 connect to the Billerica public water supply system that are constructing or erecting new or
16 expanded buildings or otherwise developing land for industrial, commercial and residential uses.
17 The method and amount of such payments from said applicants or developers shall be
18 determined by a schedule of fees to be established by the board of selectmen upon
19 recommendation by the director of public works, as provided in the Billerica water conservation
20 policy. Said schedule of fees shall provide the method for determining the amount of each
21 payment from such applicants or developers based upon their anticipated water use for each type
22 of proposed development.

23 SECTION 3. In addition to the aforementioned fees, monies may also be deposited into
24 said special account from gifts, grants and donations received from public or private sources,
25 from federal and state funding programs available to the town and from any other source
26 authorized by law. Furthermore, appropriation may be made into said special account, from time
27 to time, by the town of Billerica for the purposes of providing additional funds for the aforesaid
28 water conservation and management purposes.

29 SECTION 4. The treasurer of the town of Billerica shall be authorized to invest monies
30 deposited in said special account, and the interest accruing shall inure to the benefit of said
31 special account. Said special account shall be maintained in accordance with generally accepted
32 accounting principles, and shall be audited annually with the cost of such audit charged to said
33 special account.

34 SECTION 5. The director of public works for the town of Billerica, with the approval of
35 the town manager, may make applications for available state and federal government grants for

36 the design, construction, management, conservation and rehabilitation of public water supply
37 facilities, and pledge any and all such sums for money in said account with the approval of the
38 board of selectmen and the town meeting for any matching grants for such design, construction,
39 management, conservation and rehabilitation activities.

40 SECTION 6. The town accountant shall file jointly with the board of selectmen, the town
41 manager, the treasurer, the finance committee and the bureau of accounts, a written report
42 relative to such special account authorized herein by this act. Said report shall be made within
43 120 days following closure of the books of account for each fiscal year. Such report shall include
44 a financial statement relating to the operation, maintenance and expenditures made under said the
45 special account. The board of selectmen may review and comment on said report and file such
46 review with the state auditor.
