An Act relative to towing storage..

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1	SECTION 1. Section 25 of chapter 255 of the General Laws, as appearing in the 2006
2	Official Edition, is hereby amended by inserting, after the first paragraph, the following
3	paragraph:-

4 Said person(s) shall notify the lien holder of record as listed in the Massachusetts 5 Registry of Motor Vehicle records that he/she is in possession of said motor vehicle. Said 6 notification shall be sent via certified mail no later than 15 days from the date possession of the 7 vehicle is obtained and shall state the name of the vehicle owner, the date possession was 8 obtained, the make and model of the vehicle and an itemization of the storage charges and any 9 other duly authorized work performed on the vehicle. If notification is not provided as indicated 10 in this paragraph then any lien shall not exceed the total sum of 15 days of storage charges and 11 any other work performed as listed in the notification.

SECTION 2. Section 26 of chapter 255 of the General Laws, as appearing in the 2006
Official Edition, is hereby amended by deleting in line 6 the word "twenty-five", and inserting in
line 7, after "within ten days", the following text:-

17	SECTION 3. Section 26 of chapter 255 of the General Laws, as appearing in the 2006

21	exceed the total sum of 15 days of storage charges and any other work performed as listed in the
