An Act RELATIVE TO THE PAYMENT OF PENSION BENEFITS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

Under no circumstances 11 shall such payments be recoverable by such member after such period of incarceration."
- SECTION 3. M.G.L. c.32, §26 is hereby amended by inserting the following subsection:
 - "(5) Payments to a member retired under the provisions of this section who is
