## The Commonwealth of Massachusetts

In the Year Two Thousand Nine

An Act relative to expanding energy efficiency in the Commonwealth..

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:* 

1	Section 1. (A) Section 2 of chapter 25B of the general laws as appearing in the 2006
2	official edition, is hereby amended by inserting, after line 8, the following: -
3	"Bottle-type water dispenser" means a water dispenser that uses a bottle or reservoir as
4	the source of potable water."
5	(B) Said section 2 of said chapter 25B of the general laws, as so appearing, is hereby
6	further amended by inserting, after line 10, the following: -
7	"Combination television" means a system in which a television or television monitor and
8	an additional device or devices including, but not limited to, a DVD player, an HDD player or a
9	VCR, are combined into a single unit and which meets all of the following criteria: the additional
10	devices are included in the television casing;
11	"Commercial hot food holding cabinet" means a heated, fully-enclosed compartment
12	with one or more solid or glass doors that is designed to maintain the temperature of hot food

that has been cooked in a separate appliance. It shall not include heated glass merchandizingcabinets, drawer warmers, or cook-and-hold appliances.

(C) Said Section 2 of said chapter 25B of the general laws, as so appearing, is further
 amended by inserting, after line 11, the following: -

17 "Compact audio product," also known as a mini, mid, micro, or shelf audio system, 18 means an integrated audio system encased in a single housing that includes an amplifier and 19 radio tuner, attached or separable speakers, and can reproduce audio from one or more of the 20 following media: magnetic tape, CD, DVD, or flash memory. "Compact audio product" does 21 not include products that can be independently powered by internal batteries or that have a 22 powered external satellite antenna, or that can provide a video output signal."

- 23 "Component television" means a television composed of two or more separate
  24 components (e.g., separate display device and tuner) marketed and sold as a television under one
  25 model or system designation. The system may have more than one power cord."
- 26 "Computer monitor" means an analog or digital device designed primarily for the display
  27 of computer generated signals, is "plug and play," and is not marketed for use as a television."
- (D) Said section 2 of said chapter 25B of the general laws, as so appearing, is hereby
  further amended by inserting the following language after line 13:
- 30 "Digital versatile disc" and "DVD" mean a laser-encoded plastic medium capable of
  31 storing a large amount of digital audio, video, and computer data."
- 32 "Digital versatile disc player" and "digital versatile disc recorder" mean commercially-33 available electronic products encased in a single housing that includes an integral power supply

34	and for which the sole purpose is, respectively, (1) the decoding and (2) production or recording
35	of digitized video signal on a DVD. "DVD recorder" does not include models that have an
36	electronic programming guide function that provides an interactive, onscreen menu of television
37	listings, and that downloads program information from the vertical blanking interval of a regular
38	television signal."
39	(E) Said section 2 of said chapter 25B of the general laws, as so appearing, is hereby
40	further amended by inserting, after line 54, the following: -
41	"On mode" means the television is connected to a power source and produces sound and
42	a picture."
43	"Portable electric spa" means a factory-built electric spa or hot tub, supplied with
44	equipment for heating and circulating water."
45	"Portable luminaire" means a luminaire which connects to a power supply by means of a
46	power cord and plug."
47	(F) Said section 2 of said chapter 25B of the general laws, as so appearing, is hereby
48	further amended by inserting, after line 102, the following: -
49	"Standby-passive mode" means the television is connected to a power source, produces
50	neither sound nor images but can be switched into another mode with a remote control unit or an
51	internal signal."
52	(G) Said section 2 of said chapter 25B of the general laws, as so appearing, is hereby
53	further amended by inserting, after line 115, the following: -

54	"Television" means an analog or digital device designed primarily for the display and
55	reception of a terrestrial, satellite, cable internet protocol tv (IPTV) or other broadcast or
56	recorded transmission of analog or digital signals. Televisions include combination televisions,
57	television monitors, component televisions, and any product that is marketed as a television.
58	Televisions do not include computer monitors."
59	"Television monitor" means a television that does not have an internal tuner or receiver
60	or playback device."
61	(H) Said section 2 of said chapter 25B of the general laws, as so appearing, is hereby
62	further amended by inserting, after line 127, the following: -
63	"Water dispenser" means a factory –made assembly that mechanically cools and heats
64	potable water and that dispenses the cooler or heated water by integral or remote means."
65	Section 2. (A) section 3 of chapter 25B of the general laws, as so appearing, is hereby
66	amended by inserting, after subsection (j) the following subsections: -
67	(k) bottle-type water dispensers;
68	(1) commercial hot food holding cabinets;
69	(m) compact audio products;
70	(n) digital versatile disc players (DVD) and digital versatile disc recorders;
71	(o) portable electric spas;
72	(p) portable luminaires

73	(q) televisions (TVs); and

74	(r) any other products as may be designated by the Commissioner in accordance with
75	Section 7 of Chapter 25 of the general laws.
76	(B) Said section 3 of said chapter 25B of the general laws, as so appearing, is hereby
77	further amended by inserting, after line 29, the following: -
78	"; or new products manufactured in the state and sold outside the state; new products
79	manufactured outside the state and sold at wholesale inside the state for final retail sale and
80	installation outside the state; products installed in mobile manufactured homes at the time of
81	construction; or products designed expressly for installation and use in recreational vehicles"
82	Section 3. (A)Section 4 of chapter 25B of the general laws, as so appearing, is hereby
83	amended by striking out the words "clauses (a) to (e) in line 1, and inserting in place thereof the
84	words "clauses (a) to (r)
85	(B) Said section 4 of said chapter 25B of the general laws, as so appearing, is hereby
86	further amended by striking out the words "clauses (a) to (e) in line 6 and inserting in place
87	thereof the words "clauses (a) to (r)
88	Section 4. (A) Section 5 of chapter 25B of the general laws, as so appearing, is hereby
89	amended by inserting, after the word "ninety" in line 12 the following language: -
90	"Said commissioner may also by regulation increase the level of energy efficiency
91	standards for bottle -type water dispensers, commercial hot food holding cabinets, compact
92	audio products, digital versatile disc players (DVDs) and recorders, portable luminaries, portable
93	electric spas, and televisions (TVs).

94	(B) Said section 5 of said chapter 25B of the general laws, as so appearing, is hereby
95	further amended by inserting, after the word "users" in line 14, the following: -
96	"and promote energy conservation in the commonwealth,"
97	Said section 5 of said chapter 25B of the general laws, as so appearing, is hereby further
98	amended by striking out the words "clauses (f) to (s) in line 23 and inserting in place thereof the
99	words "clauses (a) to (r)".
100	(C) Said section 5 of said chapter 25B of the general laws, as so appearing, is hereby
101	further amended by inserting, after subsection (5) the following subsections: -
102	(6) Bottle-type water dispensers designed for dispensing both hot and cold water shall not
103	have standby energy consumption greater than 1.2 kilowatt-hours per day, as measured in
104	accordance with the test criteria contained in version 1 of the U.S. environmental protection
105	agency's "Energy Star Program Requirements for Bottled Water Coolers," except units with an
106	integral, automatic timer shall not be tested using Section D, "timer usage," of the test criteria.
107	(7) Commercial hot food holding cabinets shall have a maximum idle energy rate of 40
108	watts per cubic foot of interior volume, as determined by the "idle energy rate-dry test" in ASTM
109	F2140-01, "Standard Test Method for Performance of Hot Food Holding Cabinets" published by
110	ASTM International. Interior volume shall be measured in accordance with the method shown in
111	the U.S. environmental protection agency's "Energy Star Program Requirements for Commercial
112	Hot Food Holding Cabinets" as in effect on August 15, 2003.
113	Compact audio products shall not use more than 2 watts in standby-passive mode for
114	those without a permanently illuminated clock display and 4 watts in standby-passive mode for

115	those with a permanently illuminated clock display, as measured in accordance with the
116	international electrotechnical commission (IEC) test method 62087:2002(E), "Methods of
117	measurement for the power consumption of audio, video, and related equipment."
118	Digital versatile disc players and digital versatile disc recorders shall not use more than 3
119	watts in standby-passive mode, as measured in accordance with international electrotechnical
120	commission (IEC) test method 62087:2002(E), "Methods of measurement for the power
121	consumption of audio, video, and related equipment."
122	(10) Portable luminaires shall meet one or more of the following requirements:
123	(i) Be equipped with a dedicated fluorescent lamp socket connected to a high frequency
124	electronic ballast contained within the luminaire. Dedicated fluorescent luminaires must meet the
125	requirements of the U.S. environmental protection agency's "Energy Star Program for
126	Residential Light Fixtures Version 4.2".
126 127	Residential Light Fixtures Version 4.2". (ii) Be equipped with only GU-24 line voltage sockets and not be rated for use with

Minimum Color Rendering Index (CRI): 75

136	(iv) Be equipped with an E12, E17, or E26 screw-based socket and be prepackaged and
137	sold together with one screw-based compact fluorescent lamp or screw-based LED lamp for each
138	screw-based socket on the luminaire. The compact fluorescent or LED lamps prepackaged with
139	the luminaire shall be fully compatible with any luminaire controls incorporated into the
140	luminaire (e.g., luminaires with dimmers shall be packed with dimmable lamps). Compact
141	fluorescent lamps prepackaged with luminaires shall meet the requirements of the U.S.
142	Environmental Protection Agency's Energy Star Program for CFLs Version 4.0.
143	(v) Be equipped with one or more single-ended, non-screw based halogen lamp sockets
144	(line or low voltage), a dimmer control or high-low control, and be rated for a maximum of
145	100W.
146	Artwork luminaires that meet all of the following requirements are not required to be
147	prepackaged and sold together with compact fluorescent or LED lamps: -
148	(a) designed only to be mounted directly to art work only for the purpose of illuminating
149	that art work;
150	(b) fitted only with E-12 screw-based line-voltage sockets;
151	(c) having no more than three sockets per luminaire; and
152	(d) controlled with an integral high/low switch.
153	Art work luminaires with a single socket shall have a maximum relamping rated wattage
154	of 25 watts, luminaires with two or three sockets shall have a maximum relamping rated wattage

of 15 watts per socket, as listed on a permanent label in accordance with UnderwritersLaboratories (UL) 153.

(11) Portable electric spas shall not have a standby power greater than 5(V2/3) Watts
where V=the total volume in gallons, as measured in accordance with the test method for
portable electric spas contained in section 1604, title 20, California code of regulations.

160 (12) Televisions shall use no more than (0.20\*screen area (in2) + 32) watts in on mode 161 and no more than one (1) watt in standby-passive mode. On and after January 1, 2013, 162 televisions shall use no more than (0.12\* screen area (in2) + 25) watts in on mode and no more 163 than one (1) watt in standby passive mode. Television on mode energy use shall be measured 164 according to International Electrotechnical Commission (IEC) 62087, Edition 2.0 "Methods of 165 Measurement for Power Consumption of Audio, Video, and Related Equipment," as applied by 166 the U.S. Environmental Protection Agency in the "Energy Star Program Requirements for 167 Televisions, Version 3.0" Television standby-passive mode energy use shall be measured 168 according to international electrotechnical commission (IEC) 62301, Edition 1.0: household 169 electrical appliances -measurement of standby power," as applied by the U.S. environmental 170 protection agency in the "Energy Star Program Requirements for Televisions, Version 3.0"

(D) Said section 5 of said chapter 25B of the general laws, as so appearing, is hereby
further amended by inserting, in line 75, after the figure "2008" the following: -

"On or after January 1, 2011, no new bottle-type water dispenser, commercial hot food
holding cabinet, compact audio product, digital versatile disc player or digital versatile disc
recorder, portable electric spa, portable luminaire or television may be sold or offered for sale in
