By Ms. Walz of Boston, a petition (accompanied by bill, House, No. 1082) of Martha M. Walz and others relative to vocational technical education. Education.

The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act relative to vocational technical education.

Whereas, The deferred operation of this act would tend to defeat its purpose, which is to increase the capacity of vocational technical programs , therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 1 of Chapter 74 of the General Laws, as appearing in the 2008  
2 Official Edition, is hereby amended by striking lines 43 to 44, inclusive, and inserting in place  
3 thereof the following section:-

4 “Service programs”, the preparation of students in occupational areas such as hotel and  
5 lodging, cosmetology, child care or any service occupation that by its nature is characterized as  
6 being a service, professional or non-professional. Such programs shall be in compliance with the  
7 program approval criteria regulations published by the state board.

8 SECTION 2. There is hereby established a commission on vocational-technical education  
9 in the twenty first century, to investigate and study the feasibility of authorizing public  
10 vocational-technical high schools to award post-secondary associates degrees. The commission  
11 shall consist of 14 members: 2 members of the house of representatives, to be appointed by the

12 speaker of the house; 2 members of the senate, to be appointed by the senate president; 4  
13 members to be appointed by the Massachusetts Association of Vocational Administrators; the  
14 secretary of education who shall serve as chair of the commission or a designee; 3 individuals to  
15 be appointed by the governor; the commissioner of higher education or a designee; and the  
16 commissioner of workforce development or a designee. The commission shall report to the  
17 general court the results of its investigation and study and its recommendations, if any, together  
18 with any drafts of legislation necessary to carry out such recommendations, by filing the same  
19 with the clerks of the senate and house who shall forward the same to the chairs of the joint  
20 committee on education on or before December 31, 2011.

21 SECTION 3. Subsection (a) of Section 13 of Chapter 13 of the General Laws, as  
22 appearing in the 2008 Official Edition, is hereby amended by striking the figure "17" in line 1  
23 and inserting in place thereof the following figure:-

25 SECTION 4. Subsection (a) of Section 13 of said chapter 13, as so appearing, is hereby  
26 amended by striking the word "consumers." in line 8, and inserting in place thereof the following  
27 words:-

28 consumers; and a vocational-technical licensed practical nursing educator or  
29 administrator who shall be selected from a group of three nominees, to be nominated by the  
30 Massachusetts Association of Vocational Administrators.

31 SECTION 5. Section 32 of said chapter 13, as so appearing, is hereby amended by  
32 striking the word "eight" in line 4 and inserting in place thereof the following word:-

34           SECTION 6. Section 32 of said chapter 13, as so appearing, is hereby amended by  
35 inserting after the word "forty-one." in line 8 the following sentence:-

36           One of said appointees shall be a vocational-technical electrical educator or  
37 administrator, who shall be selected from a group of three nominees, to be nominated by the  
38 Massachusetts Association of Vocational Administrators.

39           SECTION 7. Section 36 of said chapter 13, as so appearing, is hereby amended by  
40 striking the word "nine" in line 3 and inserting in place thereof the following word:-

42           SECTION 8. Section 36 of said chapter 13, as so appearing, is hereby amended by  
43 inserting, after the words "systems," in line 16 the following words:-

46 Association of Vocational Administrators,
