An Act providing security to consumers for purchases from certain vendors.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 8 of chapter 64H of the General Laws, as appearing in the 2006  
2 Official Edition, is hereby amended by adding the following subsection:-

3           (j) Every vendor providing retail sales or services in a booth, tent, table, kiosk, or other  
4 space that is not the vendor’s fixed building site, shall obtain a surety bond from a licensed  
5 insurance or surety company, guaranteeing repayment of a consumer’s purchase price in the  
6 event of a return by a consumer. The bond shall be written to provide surety for a period of 1  
7 year from date of sublease or license issuance. Any landlord providing sublease space or a  
8 license to use any premises for such retail activity shall be provided a copy of said bond prior to  
9 issuing a sublease or license to use any portion of the premises for such activity and shall retain a  
10 copy of such bond for a period of one year following expiration of the bond. Any city or town

11 authorizing the use of such non-fixed building site for retail sales or services shall be provided a  
12 copy of the above-described surety bond prior to issuing a vendor's license and shall retain a  
13 copy for a period of one year following issuance Every vendor contemplated in this subsection  
14 shall display in a conspicuous site a copy of such bond. Every bond shall be written to guarantee  
15 a minimum return amount of up to \$1000 for a single purchase. All other lawful rights and  
16 remedies shall remain available to any consumer affected by this subsection.
