An Act to clarify site plan review.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 7 of Chapter 40A is hereby amended by adding the following
2 subsection: 40A:7A. Site Plan Review

3 (a) As used in this section, "site plan review" shall mean review and approval under a
4 municipality's zoning ordinance or by-law, by an authority other than the zoning administrator,
5 of a proposed use of land or structures that does not require a special permit or a variance,
6 whether to determine whether a proposed use of land or structures is in compliance with the
7 ordinance or by-law, to evaluate the proposed use of land or structures, to consider site design
8 alternatives or otherwise.

9 (b) In addition to the home rule authority of cities and towns to require site plan
10 review, a municipality may adopt a local ordinance or by-law under this section requiring site

11 plan review and approval by a designated authority before a building permit is granted for the
12 use of land or structures governed by a zoning ordinance or by-law. The approving authority may
13 adopt, and from time to time amend, rules and regulations to implement the local site plan review
14 ordinance or by-law, including provisions for the imposition of reasonable fees for the
15 employment of outside consultants in the same manner as set forth in section 53G of chapter 44.

16 (c) An ordinance or by-law requiring site plan review, whether adopted under this
17 section or under the municipality's home rule authority, shall comply with the provisions of this
18 and all following subsections of Section 7A. The ordinance or by-law shall establish the
19 submission, review, and approval process for applications, which may include the requirement of
20 a public hearing held pursuant to the provisions in section eleven of this chapter. Approval of a
21 site plan shall require a simple majority vote of the designated authority and shall be made within
22 the time limits prescribed by ordinance or by-law, not to exceed 90 days from the date of filing
23 of the application. If no decision is issued within the time limit prescribed, the site plan shall be
24 deemed constructively approved as provided in section 9, paragraph 11 of this chapter. The
25 submission and review process for a site plan submitted in connection with an application for a
26 special permit or variance shall be conducted with the review of such application in a
27 coordinated process.

28 (d) Site plan review may impose only those conditions that are necessary: (i) to ensure
29 substantial compliance of the proposed use of land or structures with the requirements of the
30 zoning ordinance or by-law; or (ii) to mitigate any extraordinary adverse impacts of the project
31 on adjacent properties or public infrastructure. A site plan application may be denied only on the
32 grounds that: (i) the proposed use of land or structures project does not meet the requirements set
33 forth in the zoning ordinance or by-law; (ii) the applicant failed to submit the information and

34 fees required by the zoning ordinance or by-law necessary for an adequate and timely review of
35 the design of the proposed land or structures; or (iii) it is not possible adequately to mitigate any
36 extraordinary adverse project impacts on adjacent properties or public infrastructure by means of
37 suitable site design conditions.

38 (e) Zoning ordinances or by-laws shall provide that a site plan approval granted under
39 this section shall lapse within a specified period of time, not less than two years from the date of
40 the filing of such approval with the city or town clerk, if substantial use or construction has not
41 yet begun, except as extended for good cause by the approving authority. Such extension shall
42 not include time required to pursue or await the determination of an appeal under subsection (f)
43 or Section 17. The aforesaid minimum period of two years may, by ordinance or by-law, be
44 increased to a longer period.

45 (f) Except where site plan review is required in connection with the issuance of a
46 special permit or variance, decisions made under site plan review, whether made pursuant to
47 statutory or home rule authority, may be appealed by a civil action in the nature of certiorari
48 pursuant to Chapter 249, Section 4 of the General Laws, and not otherwise. Such civil action
49 may be brought in the superior court or in the land court and shall be commenced within twenty
50 days after the filing of the decision of the site plan review approving authority with the city or
51 town clerk. All issues in any proceeding under this section shall have precedence over all other
52 civil actions and proceedings. A complaint by a plaintiff challenging a site plan approval under
53 this section shall allege the specific reasons why the project fails to satisfy the requirements of
54 this section, the zoning ordinance or by-law, or other applicable law and shall allege specific
55 facts establishing how the plaintiff is aggrieved by such decision. The approving authority's

56 decision in such a case shall be affirmed unless the court concludes that the approving authority
57 abused its discretion under subsection (d) in approving the project.

58 (g) In municipalities that adopted a zoning ordinance or by-law requiring some form
59 of site plan review prior to the effective date of this act, the provisions of this Section 7A shall
60 not be effective with respect to such zoning ordinance or by-law until the date one year after the
61 effective date of this act.
