An Act relative to promoting excellence and accountability for the education of mobile student populations.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 1I of chapter 69 of the General Laws, as appearing in the 2008  
2 Official Edition, is hereby amended by adding after the word “district”, in line 163, the following  
3 clause:-

4           (j) the number of mobile students, defined as any student who enrolled in the district for  
5 less than one academic year, and also, when attainable, the reason for student transfer in to the  
6 district.

7           SECTION 2. Section 2 of Chapter 70 of the General Laws is hereby further amended by  
8 inserting in the definition of “Foundation miscellaneous expenses,” after the word “staff” the  
9 following:

10 “plus (d) one thousand dollars multiplied by the mobile student enrollment.”

11 SECTION 3. Subject to appropriation, the department of elementary and secondary  
12 education shall develop a pilot grant program for school districts with schools with high mobile  
13 student enrollment for the purpose of developing and implementing programs to ensure the  
14 successful transition and academic success of mobile students. For the purpose of this section,  
15 mobile student shall be defined as any student who has been enrolled in a public school district  
16 for less than one academic year and mobile student enrollment shall be the average of the 3  
17 previous fiscal years of the number of mobile students enrolled. Grants shall be awarded to  
18 school districts for programs designed to (a) provide welcome and transition assistance programs  
19 for mobile students; (b) provide tutoring in core content and, as needed, English for Speakers of  
20 Other Languages; (c) assess the impact of mobile students on non-mobile student academic  
21 success; (d) provide guidance and support services targeted to mobile students; or (e) other  
22 programs determined by the department of elementary and secondary education to meet the  
23 needs of mobile students and school districts with high mobility populations. The department of  
24 elementary and secondary education may promulgate rules and regulations to carry out the  
25 provisions of this section.

26 SECTION 4. The department of education shall study the impact of the rate of student  
27 mobility on adequate yearly progress determinations for all school districts and shall issue a  
28 report of their findings as well as an annual report of MCAS test results by school district  
29 comparing test results between (a) the non-mobile student population and (b) the mobile student  
30 population; provided, that student mobility rate shall refer to the percentage of students enrolled  
31 in a public school district for less than one academic year; and provided, further, that said report  
32 shall be provided to the clerks of the senate and house of representatives who shall forward the

33 same to the chair of the senate ways and means committee, the chair of the house ways and  
34 means committee, and the house and senate chairs of the joint committee on education on or  
35 before December 1, 2012.
