By Mr. Jones of North Reading, a petition (accompanied by bill, House, No. 2003) of Bradley H. Jones, Jr. and others for an investigation by a special commission (including members of the General Court) of producer responsibility laws related to the manufacture and post-consumer management of certain products. Environment, Natural Resources and Agriculture.

The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act establishing the commission on extended producer responsibility.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1	SECTION 1. Notwithstanding any General or Special law to the contrary, there shall be a
2	special commission, called the commission on extended producer responsibility, to study and
3	report on implementing extended producer responsibility laws in the commonwealth. The
4	commission shall consist of the secretary of energy and environmental affairs; the commissioner
5	of environmental protection; 1 member of the department of business development; 3 members
6	of the house of representatives, 2 of whom shall be appointed by the speaker of the house, and 1
7	of whom shall be appointed by the minority leader of the house; 3 members of the senate, 2 of
8	whom shall be appointed by the senate president, and 1 of whom shall be appointed by the senate
9	minority leader; and 2 members who shall be appointed by the governor.
10	The scope of the commission shall include, but not limited to: researching, evaluating,

- 11 and developing recommendations regarding the economic, environmental, and public health
- 12 benefits and costs of extended producer responsibility laws related to the manufacture and post-

13 consumer management of products including, but not limited to, the following: leftover paint, 14 electronics, pesticides, household batteries, fluorescent lamps, phone books, carpet, medical 15 sharps, consumer packaging and printed materials, pharmaceuticals, tires and mercury 16 thermostats. The commission shall also research and make recommendations regarding the 17 establishment of a comprehensive product stewardship approach, also known as a framework 18 approach, to create an statewide policy structure for product stewardship that may be applied to 19 an array of products. The commission shall consult with manufacturers, retailers, recyclers, 20 environmental advocacy organizations, local units of government, and other interested parties, 21 and shall provide at least one opportunity for public comment and the public review of the 22 commission's draft report. The commission report shall include, but not limited to, summaries 23 of the following: (1) the existing infrastructure for managing post-consumer materials and the 24 need for improvements to make this infrastructure convenient for the public; (2) the need for 25 public education to reach target populations; (3) the need for incentives to change consumer 26 behavior; (4) the current extended producer responsibility laws and pending extended producer 27 responsibility legislation in other new england states and around the country; (5) the common 28 elements of extended producer responsibility laws; (6) the opportunities to maximize the 29 efficiency of extended producer responsibility programs by coordinating with other states in the 30 region; and (7) the methods for evaluating the effectiveness of extended producer responsibility 31 programs.

The commission shall submit its report of the findings and recommendations together with recommendations for legislation to implement those recommendations by filing the same with the executive office of energy and environmental affairs; the department of environmental protection; the department of business development; the joint committee on environment, natural
