An Act relative to the treatment of cleft palate and cleft lip.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Chapter 32A of the General Laws, as appearing in the 2006 Official  
2 Edition, is hereby amended by adding the following section:

3           Section 17J. Notwithstanding any general or special law or rule or regulation to the  
4 contrary, a health insurance policy that covers a child under the age of 18 must provide coverage  
5 for treatment of cleft lip and cleft palate for the child. The coverage must include benefits for  
6 medical, dental, oral and facial surgery, surgical management and follow-up care by oral and  
7 plastic surgeons, orthodontic treatment and management, preventative and restorative dentistry to  
8 insure good health and adequate dental structures for orthodontic treatment or prosthetic  
9 management therapy, speech therapy, audiology, and nutrition services, only if such services are  
10 prescribed by the treating physician or surgeon and such physician or surgeon certifies that such

11 services are medically necessary and consequent to the treatment of the cleft lip or palate. The  
12 coverage required by this section is subject to the terms and conditions applicable to other  
13 benefits. Payment for dental or orthodontic treatment not related to the management of the  
14 congenital condition of cleft lip and cleft palate shall not be covered under this provision.

15 SECTION 2. Chapter 118E, is hereby amended by adding the following section:

16 Section 61. Notwithstanding any general or special law or rule or regulation to the  
17 contrary, a health insurance policy that covers a child under the age of 18 must provide coverage  
18 for treatment of cleft lip and cleft palate for the child. The coverage must include benefits for  
19 medical, dental, oral and facial surgery, surgical management and follow-up care by oral and  
20 plastic surgeons, orthodontic treatment and management, preventative and restorative dentistry to  
21 insure good health and adequate dental structures for orthodontic treatment or prosthetic  
22 management therapy, speech therapy, audiology, and nutrition services, only if such services are  
23 prescribed by the treating physician or surgeon and such physician or surgeon certifies that such  
24 services are medically necessary and consequent to the treatment of the cleft lip or palate. The  
25 coverage required by this section is subject to the terms and conditions applicable to other  
26 benefits. Payment for dental or orthodontic treatment not related to the management of the  
27 congenital condition of cleft lip and cleft palate shall not be covered under this provision.

28 SECTION 3. Section 108 of Chapter 175 is hereby amended by adding the following  
29 section:

30 Section K. Notwithstanding any general or special law or rule or regulation to the  
31 contrary, a health insurance policy that covers a child under the age of 18 must provide coverage  
32 for treatment of cleft lip and cleft palate for the child. The coverage must include benefits for

33 medical, dental, oral and facial surgery, surgical management and follow-up care by oral and  
34 plastic surgeons, orthodontic treatment and management, preventative and restorative dentistry to  
35 insure good health and adequate dental structures for orthodontic treatment or prosthetic  
36 management therapy, speech therapy, audiology, and nutrition services, only if such services are  
37 prescribed by the treating physician or surgeon and such physician or surgeon certifies that such  
38 services are medically necessary and consequent to the treatment of the cleft lip or palate. The  
39 coverage required by this section is subject to the terms and conditions applicable to other  
40 benefits. Payment for dental or orthodontic treatment not related to the management of the  
41 congenital condition of cleft lip and cleft palate shall not be covered under this provision.

42 SECTION 4. Section 110 of Chapter 175 is hereby amended by adding the following  
43 section:

44 Section N. Notwithstanding any general or special law or rule or regulation to the  
45 contrary, a health insurance policy that covers a child under the age of 18 must provide coverage  
46 for treatment of cleft lip and cleft palate for the child. The coverage must include benefits for  
47 medical, dental, oral and facial surgery, surgical management and follow-up care by oral and  
48 plastic surgeons, orthodontic treatment and management, preventative and restorative dentistry to  
49 insure good health and adequate dental structures for orthodontic treatment or prosthetic  
50 management therapy, speech therapy, audiology, and nutrition services, only if such services are  
51 prescribed by the treating physician or surgeon and such physician or surgeon certifies that such  
52 services are medically necessary and consequent to the treatment of the cleft lip or palate. The  
53 coverage required by this section is subject to the terms and conditions applicable to other  
54 benefits. Payment for dental or orthodontic treatment not related to the management of the  
55 congenital condition of cleft lip and cleft palate shall not be covered under this provision.
