By Ms. Garlick of Needham, a petition (accompanied by bill, House, No. 2320) of Denise C. Garlick and Richard J. Ross (by vote of the town) relative to authorizing the town of Needham to dispose of by sale certain conservation land and to grant a permanent ground bed easement to support natural gas transmission. An Act relative to authorizing the town of Needham to dispose of by sale of 375 square feet of conservation land and to grant a permanent ground bed easement to support natural gas transmission under article of amendment XLIX.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 1. The Town of Needham is authorized to sell 375 square feet, more or less, off

2 of Mary Chilton Road, for the purposes of operating and maintaining a gas transmission line

3 utility.

4	Section 2. The Town of Needham is authorized to change the use of 18,764 square feet,
5	more or less, of land at Ridge Hill Reservation, 461 Charles River Street, Needham,
6	Massachusetts, as described on a plan entitled "Ridge Hill Cathodic Protection System
7	Permitting Plan prepared by Vanasse Hangen Brustlin, Inc.," from conservation to municipal
8	use, for the purpose of installing and maintaining a cathodic protection system for a gas
9	transmission line.

10	Section 3. The Town of Needham is authorized to grant and convey a cathodic protection
11	easement of 19,564 square feet, more or less, within the land known as Ridge Hill Reservation,
12	461 Charles River Street, Needham, Massachusetts, as described on a plan entitled "Ridge Hill
13	Cathodic Protection System Permitting Plan prepared by Vanasse Hangen Brustlin, Inc.," for the
14	purpose of installing and maintaining a cathodic protection system for a gas transmission line.
