**HOUSE . . . . . No. 2700**

By Mr. McMurtry of Dedham, a petition (accompanied by bill, House, No. 2700) of Paul McMurtry and others for legislation to authorize the issuance of annual licenses for the sale of all alcoholic beverages to be drunk on the premises to operators of catering businesses. Consumer Protection and Professional Licensure.

**The Commonwealth of Massachusetts**

**In the Year Two Thousand Eleven**

An Act The Private Function Caterers' Act of 2011.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           Whereas, caterers are in the business of accomodating their customers wishes at private  
2 parties; Whereas, catering private functions is one of the economic engines driving growth in the  
3 hospitality industry; Whereas, hosts at private functions very often request service of beverage  
4 alcohol for their guests; Whereas, the general public interests are best served by the responsible  
5 service of alcohol by trained professionals; Whereas, the need exists for the Commonwealth to  
6 address alcohol service at private functions; now, therefore may

7           Massachusetts General Law Chapter 138, Section 12, as most recently amended, is  
8 further amended by adding the following paragraph:

9           The Commission may issue an annual caterer’s license to an operator of a catering  
10 business for the sale and service of all alcoholic beverages to be served and drunk on the  
11 premise(s) where the operator is catering a private event that is not open to the public, provided  
12 the premise(s) is in a city or town where the granting of a license under §12 to sell alcoholic

13 beverages is authorized. The holder of a caterer's license shall purchase all alcoholic beverages  
14 for resale from a wholesaler licensed pursuant to §18 and shall maintain liquor liability insurance  
15 providing security for the liability of the licensee in a minimum amount of \$250,000 on account  
16 of injury to or death of more than one (1) person. The service of alcoholic beverages shall not be  
17 for more than five (5) hours during any catered event. All agents and employees of a licensed  
18 caterer who serve alcoholic beverages shall be certified by a nationally recognized alcoholic  
19 beverages server training program. The decision of the Commission shall be final and  
20 conclusive.

21 A caterer's license shall authorize the licensee to store, transport and deliver alcoholic  
22 beverages in the ordinary course of the licensee's business. Alcoholic beverages may be stored  
23 only on premises owned by the licensee or that the licensee has the exclusive right to occupy.  
24 The license shall be renewable annually and the annual fee shall be two thousand five hundred  
25 dollars (\$1,500).

26 The Commission after notice to the licensee and reasonable opportunity to be heard may  
27 modify, suspend, revoke or cancel the license upon satisfactory proof that the licensee violated or  
28 permitted a violation of any condition thereof, any law of the Commonwealth or any regulation  
29 of the Commission.
