In the Year Two Thousand Eleven

AN ACT PROVIDING FOR THE SAFETY OF VULNERABLE ROAD USERS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1: Section 1 of chapter 90 of the General Laws, as appearing in the 2008
2 Official Edition, is hereby amended by inserting after line [], the following sentence:-
3 ““Vulnerable user” means a pedestrian or a person operating a bicycle, handcycle, tricycle,
4 skateboard, roller skates, in-line skates, or non-motorized scooter.”.

5 SECTION 2: The first sentence of paragraph (a) of Section 24G of chapter 90 of the
6 General Laws, as appearing in the 2008 Official Edition, is hereby amended by inserting after the
7 first occurrence of the word “dollars”, in line [], the following words:- “(ten thousand dollars if
8 the victim is a vulnerable user as defined in section one of chapter ninety)”.

9 SECTION 3: The first sentence of paragraph (a) of Section 24G of chapter 90 of the
10 General Laws, as appearing in the 2008 Official Edition, is hereby amended by inserting after the
11 second occurrence of the word “dollars”, in line [], the following words:- “(ten thousand dollars
12 if the victim is a vulnerable user as defined in section one of chapter ninety)”.

13 SECTION 4: The first sentence of paragraph (b) of Section 24G of chapter 90 of the
14 General Laws, as appearing in the 2008 Official Edition, is hereby amended by inserting after the
15 word “dollars”, in line [], the following words:- “(not less than six hundred nor more than six
16 thousand dollars if the victim is a vulnerable user as defined in section one of chapter ninety)”.

17 SECTION 5: Section 24G of chapter 90 of the General Laws, as appearing in the 2008
18 Official Edition, is hereby amended by inserting after paragraph (c), in line [], the following
19 paragraph:- “(d) A person convicted of a violation of this section where the victim is a vulnerable
20 user as defined in section one of chapter ninety shall, in addition to such imprisonment and fines
21 as provided in this section, be required to complete a traffic safety class including interactions
22 between motorized vehicles and vulnerable users, and to perform up to 100 hours of community
23 service related to driver improvement and providing public education on traffic safety including
24 interactions between motorized vehicles and vulnerable users.”

25 SECTION 6: The first sentence of subdivision (1) of Section 24L of chapter 90 of the
26 General Laws, as appearing in the 2008 Official Edition, is hereby amended by inserting after the
27 first occurrence of the word “dollars”, in line [], the following words:- “(ten thousand dollars if
28 the victim is a vulnerable user as defined in section one of chapter ninety)”.

29 SECTION 7: The first sentence of subdivision (1) of Section 24L of chapter 90 of the
30 General Laws, as appearing in the 2008 Official Edition, is hereby amended by inserting after the
31 second occurrence of the word “dollars”, in line [], the following words:- “(ten thousand dollars
32 if the victim is a vulnerable user as defined in section one of chapter ninety)”.

33 SECTION 8: The first sentence of subdivision (2) of Section 24L of chapter 90 of the
34 General Laws, as appearing in the 2008 Official Edition, is hereby amended by inserting after the

35 word “glue”, in line [], the following words:- “, or whoever operates a motor vehicle recklessly
36 or negligently so that the lives or safety of the public might be endangered”.

37 SECTION 9: The first sentence of subdivision (2) of Section 24L of chapter 90 of the
38 General Laws, as appearing in the 2008 Official Edition, is hereby amended by inserting after the
39 word “dollars”, in line [], the following words:- “(not less than six thousand dollars if the victim
40 is a vulnerable user as defined in section one of chapter ninety)”.

41 SECTION 10: Section 24L of chapter 90 of the General Laws, as appearing in the 2008
42 Official Edition, is hereby amended by inserting after subdivision (4), in line [], the following
43 subdivision:- “(5) A person convicted of a violation of this section where the victim is a
44 vulnerable user as defined in section one of chapter ninety shall, in addition to such
45 imprisonment and fines as provided in this section, be required to complete a traffic safety class
46 including interactions between motorized vehicles and vulnerable users, and to perform up to
47 100 hours of community service related to driver improvement and providing public education
48 on traffic safety including interactions between motorized vehicles and vulnerable users.”

49 SECTION 11: The first sentence of subparagraph (1) of paragraph (a1/2) of subdivision
50 (2) of Section 24 of chapter 90 of the General Laws, as appearing in the 2008 Official Edition, is
51 hereby amended by inserting after the second occurrence of the word “dollars”, in line [], the
52 following words:- “(not less than one thousand dollars nor more than two thousand dollars if the
53 victim is a vulnerable user as defined in section one of chapter ninety)”.

54 SECTION 12: The first sentence of subparagraph (2) of paragraph (a1/2) of subdivision
55 (2) of Section 24 of chapter 90 of the General Laws, as appearing in the 2008 Official Edition, is
56 hereby amended by inserting after the second occurrence of the word “dollars”, in line [], the

57 following words:- “(not less than two thousand dollars nor more than ten thousand dollars if the
58 victim is a vulnerable user as defined in section one of chapter ninety)”.

59 SECTION 13: The first sentence of subparagraph (2) of paragraph (a1/2) of subdivision
60 (2) of Section 24 of chapter 90 of the General Laws, as appearing in the 2008 Official Edition, is
61 hereby amended by inserting after the fourth occurrence of the word “dollars”, in line [], the
62 following words:- “(not less than two thousand dollars nor more than ten thousand dollars if the
63 victim is a vulnerable user as defined in section one of chapter ninety)”.

64 SECTION 14: Subdivision (3) of Section 24 of chapter 90 of the General Laws, as
65 appearing in the 2008 Official Edition, is hereby amended by inserting after paragraph (c), in line
66 [], the following paragraph:- “(d) A person convicted of a violation of subparagraph (1) or
67 subparagraph (2) of paragraph (a 1/2) of subdivision (2) where the victim is a vulnerable user as
68 defined in section one of chapter ninety shall, in addition to such imprisonment and fines as
69 provided in this section, shall be required to complete a traffic safety class including interactions
70 between motorized vehicles and vulnerable users, and to perform up to 100 hours of community
71 service related to driver improvement and providing public education on traffic safety including
72 interactions between motorized vehicles and vulnerable users.”

73 SECTION 15: The first sentence of subparagraph (1) of paragraph (a1/2) of subdivision
74 (2) of Section 24 of chapter 90 of the General Laws, as appearing in the 2008 Official Edition, is
75 hereby amended by inserting after the word “knowingly”, in line [], the following words:- “,
76 recklessly or negligently”.

77 SECTION 16: The first sentence of subparagraph (2) of paragraph (a1/2) of subdivision
78 (2) of Section 24 of chapter 90 of the General Laws, as appearing in the 2008 Official Edition, is

79 hereby amended by inserting after the word “knowingly”, in line [], the following words:- “,
80 recklessly or negligently”.
