#### The Commonwealth of Alassachusetts

An Act relative to the exposure of public safety officials to the aids virus.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Paragraph one of Section 7\_OF of Chapter 111 of the General Laws, as

- 5 SECTION 2. Section 70F of Chapter 111 of the General Laws shall be further amended
- 6 by inserting after the fourth paragraph the following: -- Provided, however, that a police officer
- 7 or other law enforcement official, fire
- 8 (b) fighter, emergency medical technician or medical personnel, or other public safety
- 9 official, who, in the course of his official duties, is bitten or scratched by a person, is stabbed or

scratched by a hypodermic needle in the possession of that person, or is otherwise exposed to the
transfer of blood, semen, or other bodily fluid on, upon, or through, his skin or membranes by
that person, and where that person is the subject of a criminal complaint or indictment, the
exposed official may petition the court having jurisdiction of the complaint or indictment for an
order compelling the subject of the complaint or indictment to be tested for the HLTV-III
