By Representative Linsky of Natick and Senator Spilka, a joint petition (accompanied by bill, House, No. 3332) of David Paul Linsky and others (by vote of the town) that the town of Natick be authorized to lease the former East School for up to ninety-nine years. Municipalities and Regional Government. [Local Approval Received.]

The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act authorizing the town of Natick to allow a lease of up to ninety-nine years for the former East School.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 1. Notwithstanding the provisions of Chapter 40, Section 3 of the
2 Massachusetts General Laws, or any general or special law to the contrary, the Natick Board of
3 Selectmen is authorized to issue a Request for Proposals to lease for a term not to exceed ninety-
4 nine (99) years (including any extension or renewal terms) the property at 84 Oak Street in
5 Natick, MA, which is now or formerly the site of the East School, and which would authorize the
6 Board of Selectmen to enter into a lease for said property for a term not to exceed ninety-nine
7 (99) years (including any extension or renewal terms).

8 Section 2. The Natick Board of Selectmen is authorized to issue a Request for
9 Proposals offering the property at 84 Oak Street for both sale and lease (such lease to be for a
10 term not to exceed ninety-nine (99) years, including any extension or renewal terms) with said
11 RFP providing an adequate mechanism for comparing the sale and lease options, provided that
12 the terms of any lease or sale must be approved by a subsequent Town Meeting, and further

13 Section 3. The Natick Board of Selectmen is authorized to appropriate the sum of
14 \$25,000 from available funds, said funds to be spent under the jurisdiction of the Natick Board of
15 Selectmen for the preparation of reports and analysis, which may include but would not be
16 limited to appraisal services, environmental assessment, asbestos and lead paint testing and
17 analysis, analysis of building systems and development of associated capital improvement
18 program, advertisements and other costs necessary to effectively market the building.

19 SECTION 4. This Act shall take effect upon its passage.
