An Act amending Chapter 51 of the Acts of 2010 to reflect the passage of Chapter 398 of the Acts of 2008 and to make certain other corrections.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 1 of chapter 51 of the acts of 2010 is hereby amended by inserting  
2 after the figure “1974” in line 1 the following: “as amended by section 1 of chapter 487 of the  
3 acts of 1996.”

4           SECTION 2. Section 1 of chapter 51 of the acts of 2010 is further amended by striking  
5 out the word “department” in the second sentence thereof and inserting in its place the word  
6 “division.”

7           SECTION 3. Section 2 of said chapter 51 of the acts of 2010 is hereby amended by  
8 striking out the words “amended by section 1 of chapter 85 of the acts of 2006” and inserting in  
9 place thereof the following: “most recently amended by chapter 398 of the acts of 2008.”

10 SECTION 4. Section 4 of said chapter 51 of the acts of 2010 is hereby amended by  
11 striking out the words “amended by section 1 of chapter 85 of the acts of 2006” and inserting in  
12 place thereof the following: “most recently amended by chapter 398 of the acts of 2008.”

13 SECTION 5. Section 4 of said chapter 51 of the acts of 2010 is further amended by  
14 striking out the word “third” in the first sentence and inserting in place thereof the word “fourth”.

15 SECTION 6. Said chapter 51 of the acts of 2010 is hereby amended by striking out  
16 section 5 and inserting in place thereof the following: “SECTION 5. The fifth paragraph of  
17 section 4 of said chapter 317 of the acts of 1974, as amended by said chapter 398 of the acts of  
18 2008, is hereby amended by inserting before the first sentence of the paragraph the following  
19 sentence: “Except as set forth herein with regard to taxi license sales, the following describes the  
20 appeal procedures applicable to any board action.”

21 SECTION 7. This act shall take effect upon its passage.
